1 On page 1, strike lines 1 through 5, inclusive and in their entirety and substitute:

2 “WHEREAS, the Howard County Housing Commission is established pursuant to authority set
3 forth in Section 12-201 of the Housing and Community Development Article of the Annotated Code of
4 Maryland (the “State Law”); and

6 WHEREAS, the Articles of Organization of the Housing Commission are adopted pursuant to
7 the State Law referenced above and are set out in Title 13, Subtitle 13 of the Howard County Code and
8 provide that the term of a member of the Housing Commission is 5 years; and

10 WHEREAS, Section 12-207(c) of the State Law provides that a political subdivision may not
11 amend the articles of organization to change the length of terms of commissioners stated in the initial
12 articles of organization and, for this reason, the term of members of the Housing Commission is 5
13 years; and”
