Be It Enacted by the County Council of Howard County, Maryland, that it adopts the 2 following changes to the Howard County Pay Plan, Position Classification Codes and Pay Grades for 3 Executive Exempt Employees: 4 5 Amend: Class Code 1215, County Auditor, to be Pay Grade P. 6 7 Section 2. And Be It Further Enacted by the County Council of Howard County, Maryland, that the 8 provisions of this Act shall apply beginning with the first pay period after its enactment. 9 10 Section 3. And Be It Further Enacted by the County Council of Howard County, Maryland, that 11 notwithstanding Section 2, the pay change made by this Act shall not apply to any employee appointed as 12 Acting County Auditor to fill temporarily the vacancy in the position of County Auditor occurring on 13 December 4, 2023. 14 15 Section 4. And Be It Further Enacted by the County Council of Howard County, Maryland that this Act 16 shall become effective 61 days after its enactment.

#### Council Bill No. 15-2024

Introduced: April 1, 2024 Auditor: Lori Buchman

### Fiscal Impact:

This legislation will result in an undetermined amount of savings to the County's General Fund. The amount of savings will be dependent upon what step the newly hired County Auditor is placed on the salary schedule.

For reference, if the newly hired County Auditor is placed at the same step on the lower pay scale as the prior County Auditor, annual savings of approximately \$28,000 (or 11 percent) would be realized.

#### Purpose:

The proposed legislation changes the pay scale for the County Auditor from Grade Q to Grade P.

### Other Comments:

On March 26, 2024, the Personnel Board approved the change to the pay plan for the County Auditor position.
