1 **WHEREAS**, §23–207 of the State Alcoholic Beverages and Cannabis Article provides
2 that the compensation for the Howard County Alcoholic Beverages Hearing Board members
3 shall be the amount set by the Howard County Council; and

5 **WHEREAS**, the County Council, having last adopted the compensation amount for
6 Alcoholic Beverages Hearing Board members in Council Resolution 142-2015, approved an
7 increase in compensation in the FY 2025 budget.

9 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
10 Maryland, this ___ day of _____, 2024 that the compensation of the Alcoholic Beverages
11 Hearing Board members for the performance of their duties shall be:

- 12 (1) For the chairperson, \$220 per meeting attended, not to exceed \$5,200 in a fiscal year
13 regardless of the number of meetings attended; and
14 (2) For the other Hearing Board members, \$200 per meeting attended, not to exceed
15 \$4,800 in a fiscal year regardless of the number of meetings attended.

17 **AND BE IT FURTHER RESOLVED** by the County Council of Howard County,
18 Maryland, that the compensation set in this Resolution shall go into effect immediately and
19 remain in effect until changed by the County Council.
