I am writing to express the Howard County Economic Development Authority's support for the passage of CB4-2025. This legislation would approve a multi-year agreement between Howard County, Maryland and Montgomery County, Maryland for the extension of the Flash bus rapid transit (BRT) to Downtown Columbia from Burtonsville, Montgomery County.

As Howard County's eminent public-private partnership working to promote economic development, HCEDA understands that quality economic development is critical to Howard County's future to ensure an adequate tax base that will maintain and sustain the high quality of life that its residents have come to expect and deserve. Transportation is an essential component to achieving those goals and the extension of the Flash system is the next step forward.

The Flash Extension project with Montgomery County will serve major employment hubs of Maple Lawn, the Johns Hopkins University Applied Physics Laboratory campus, and Downtown Columbia.
