## HOWARD COUNTY HOUSING AFFORDABILITY COALITION

County Council Public Hearing:
Long Reach Village Center Urban Renewal Contract Approval (CR 161-2024)

January 21, 2025

The Housing Affordability Coalition appreciates this opportunity to voice its support of the Long Reach Village Center Urban Renewal Project, particularly the intent to create an "Inclusive Housing Destination."

As the redevelopment project evolves, we look forward to additional details about how the forecasted 330 rental and for-sale units will help meet the proffered vision of meeting the "community's needs regardless of their age, income level, family dynamics and stages of their life." Specifically,

- Will the residential component include 20 percent Moderate Income Housing Units (MIHUs) across the multifamily apartments, senior and townhouse ownership phases?
- How many rental units will be affordable to households making 60 percent or less of AMI?
- What will be the affordability income level for the for-sale townhomes?
- What level of accessibility and visitability will there be across all units? Will those accessibility standards meet the needs of seniors and people with physical disabilities?
- Will the HoCo By Design goal of 10 percent accessibility of all affordable housing units be met?
- What amendment to the Preliminary Development Plan (PDP) zoning requirements will be required to include the proposed residential uses effectively?
- What amendments to the Final Development Plan (FDP) will be required to implement the Plan?

One issue of Coalition concern is *Destination Long Reach's* statement that if the affordable housing is put on Howard Hughes land, that that housing would be counted toward Howard Hughes' obligations under the Downtown Columbia Plan's Developers Rights and Responsibilities Agreement (DRRA). The Long Reach Village Center is not within the Downtown footprint and therefore in the Coalition's view, it would be inappropriate for such a transfer of obligation.

Thank you, Council members, for the opportunity to express the Coalition's support for CR 161. We are enthusiastic about the redevelopment of this important part of our community which will bring much needed housing and economic stimulation.

We long for Long Reach, in its developmental process to reinvest into this community, to seek out how potential changes would be equitable for those who currently reside on Tamar drive and the neighbors, be a resource for Long Reach High School students who will find the Village Center to be a refuge after school, and provide community services that cares for the poor, the orphan, and the widow, as our faith tradition reminds us, to provide essential food and clothing for those in need. In these things we hope that we open the door not just to economic opportunity for our region, but community building in a world in need of compassion and care for loving our neighbor.

Dear Ms. Walsh and members of the Council:

On behalf of the League of Women Voters of Howard County, I appreciate the opportunity to convey strong support for Council bills CR161-2024 and CR162-2024.

These bills both move the Long Reach Redevelopment and Reinvigoration project forward. The inclusion of affordable housing is in line with county goals as expressed in the General Plan and in the League's long-standing support for affordable housing. This Columbia village needs affordable housing and amenities within walking distance and the League supports the project and the land sale.

The League would also like to express strong support for CB3-2025 which approves Enterprise Community Development's request for approval of the Section 108 Loan guarantee allowing both the Ranleigh Place and Waverly woods redevelopment housing projects to proceed. For more than 50 years, these communities offered a significant number of affordable houses to low-income county residents. The properties have deteriorated significantly over time. Preservation and expansion of these properties is consistent with the General Plan that calls for existing affordable housing preservation.

There will be homes for households making 60% and below of Howard County median income and some even below 40% of median income. In addition, these projects will expand the number of accessible units for disabled county residents. Enterprise's commitment to serving the needs of this population is very welcome.
