1 **WHEREAS**, the provisions of Section 4-202.1 of the Environment Article of the Annotated
2 Code of Maryland require Howard County to file a Financial Assurance Plan (the “Plan”) with the
3 Maryland Department of the Environment (“MDE”) that demonstrates that it has sufficient funding
4 to meet the impervious surface restoration plan requirements of the County’s National Pollutant
5 Discharge Elimination System Phase I Municipal Separate Storm Sewer System Permit; and

7 **WHEREAS**, the County has worked with MDE over the past several months to craft a Plan
8 that projects and describes actions and financial resources and costs related to stormwater
9 management in Howard County over the two-year period following the filing date of the Plan; and

11 **WHEREAS**, previous Plans have been approved by the passage of Council Resolution No.
12 182-2015, Council Resolution No. 92-2016, Council Resolution No. 45-2019, Council Resolution
13 No. 41-2021 and Council Resolution No. 130-2023; and

15 **WHEREAS**, the State law requires that the County file a Plan with MDE and that the
16 governing body of the County hold a public hearing on the Plan and approve the Plan prior to filing
17 with MDE.

19 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
20 Maryland, this 7 day of April, 2025, that it hereby approves the
21 Plan, substantially in the form attached, as a projection of actions, funding, and costs of Howard
22 County’s stormwater management program over the two-year period following the filing date of
23 the Plan.

Howard County Financial Assurance Plan for Fiscal Year 2024: Executive Summary

According to the Maryland Department of the Environment's (MDE's) 2018 *Guidance for Municipal Separate Storm Sewer System Permittees for Filing Financial Assurance Plans and Watershed Protection and Restoration Program Annual Reports*:

"In May 2015, revisions to the Annotated Code of Maryland, Section 4-202, regarding the Watershed Protection and Restoration Program (WPRP) were signed into law. Previously, the law required each National Pollutant Discharge Elimination System (NPDES) Phase I municipal separate storm sewer system (MS4) jurisdiction to establish a stormwater remediation fee. These revisions have since removed that requirement (although jurisdictions still have the option of implementing a stormwater fee). However, jurisdictions are still responsible for obtaining the necessary funds to ensure that all MS4 permit requirements are satisfied. To ensure that each jurisdiction will have adequate funding, a series of requirements were added to the WPRP."

Each NPDES Phase I MS4 jurisdiction must submit to MDE a Financial Assurance Plan (FAP) every two years on the anniversary date of its MS4 permit. To date, Howard County's FAPs have been submitted for fiscal years 2016, 2018, 2020, and 2022. This Executive Summary accompanies Howard County's FAP for fiscal year 2024.

According to Annotated Code of Maryland, Section 4-202, the FAP must detail the following:

- all actions required to meet MS4 permit requirements
- annual and projected 5-year costs necessary to meet the impervious surface restoration plan (ISRP) requirement
- annual and projected 5-year revenues that will be used toward meeting the ISRP requirement
- any and all sources of funds used toward meeting MS4 permit requirements
- all specific actions and expenditures undertaken in the previous fiscal years to meet the ISRP requirement

Howard County implemented its stormwater utility fee, the Watershed Protection and Restoration Fee (WPRF), on July 1, 2013. Since that time, the WPRF and other funding sources have been applied to meet MS4 permit requirements. Howard County's 2016, 2018, and 2020 FAPs reflect funding and spending related to the requirements of the County's fourth-generation MS4 permit issued on December 18, 2014. The 2022 and 2024 FAPs reflect funding and spending related to the requirements of the County's fifth-generation (current) MS4 permit issued on December 30, 2022.

The ISRP requirement of the fourth-generation permit mandated that, by December 17, 2019, the County implement restoration efforts for 20% of its total impervious surface area that had not already been restored to the maximum extent practicable (MEP). Per MDE guidance, all restoration projects implemented following June 10, 2010, were considered restoration that applied to the County's 20% ISRP requirement. In comments dated August 7, 2020, MDE acknowledged that Howard County's restoration requirement for the 2014-2019 permit term was 20% of its 11,019-acre baseline, or 2,204 acres. MDE also acknowledged that the County met its 20% ISRP requirement in March 2018 and exceeded its 20% ISRP requirement by completing additional impervious acres of restoration and "...is commended for this significant achievement."

The County's fourth-generation NPDES MS4 permit, which expired on December 17, 2019, was administratively continued through fiscal year 2022 and remained in effect until the fifth-generation permit was issued on December 30, 2022. The fifth-generation permit includes the ISRP requirement of continuing 559.4 acres of annual practices (street sweeping, inlet cleaning) and completing an additional 1,345 acres of new impervious surface restoration through December 29, 2027. Per MDE direction, any restoration credit for projects completed after the County met the ISRP requirement for the 2014-2019 permit term apply to the ISRP requirements in the current permit term. Therefore, this fiscal year 2024 FAP reflects completed actions through fiscal year 2024 and planned actions projected through fiscal year 2028 to meet the ISRP requirement of the currently effective fifth-generation NPDES MS4 permit and through fiscal year 2029 as a five-year projection.

The fiscal year 2024 FAP includes the following tables based on MDE's spreadsheet template provided to meet the requirements of the Annotated Code of Maryland, Section 4-202:

1. **MS4 Information:** Location, contact, and ISRP requirement information
 - a. This table lists the ISRP requirements:
 - i. Continued Annual Alternative ISR: 559.4 acres
 - ii. Required ISR New Permit (ac): 1,345 acres
2. **Specific Actions (Completed) - Article 4-202.1(j)(1)(i)5: Specific actions and expenditures that the county or municipality implemented in the previous fiscal years to meet its impervious surface restoration plan requirements under its National Pollutant Discharge Elimination System Phase I Municipal Separate Storm Sewer System Permit**
 - a. This table lists all of the Best Management Practices (BMPs) completed through fiscal year 2024 for continued annual alternative ISR (509 acres) and required new permit ISR (1,307 acres).
3. **All Actions (Planned) - Article 4-202.1(j)(1)(i)1: Actions that will be required of the county or municipality to meet the requirements of its National Pollutant Discharge Elimination System Phase I Municipal Separate Storm Sewer System Permit**
 - a. This table lists the combination of continued annual alternative ISR (which are averaged over the permit term through fiscal year 27 at 446 acres) and required new permit ISR through fiscal year 2028. The total ISR projected at the end of fiscal year 2028 comes to 1,471 acres, which is 126 acres above the permit-required 1,345 acres of total ISR. A portion of the extra 126 acres will be used to replace any shortage in the continued annual alternative ISR in fiscal year 2028, however, the County plans to meet the annual obligation by the end of the permit term in December 2027.
4. **ISRP Cost - Article 4-202.1(j)(1)(i)2: Projected annual and 5-year costs for the county or municipality to meet the impervious surface restoration plan requirements of its National Pollutant Discharge Elimination System Phase I Municipal Separate Storm Sewer System Permit**
 - a. This table outlines the various operating and capital expenditures for BMPs completed in fiscal years 2019 through 2024 and projected to be completed through the end of the permit term from fiscal year 2023 through fiscal year 2028. Note that, due to the long-term life cycle of many BMPs from planning through construction completion, the costs listed are not all incurred in the fiscal year in which the costs are listed, but instead are the total of all costs associated with projects completed in each fiscal year.
5. **ISRP Revenue - Article 4-202.1(j)(1)(i)3: Projected annual and 5-year revenues or other funds that will be used to meet the cost for the county or municipality to meet the impervious surface restoration plan requirements under the National Pollutant Discharge Elimination System Phase I Municipal Separate Storm Sewer System Permit**

- a. This table compares annual revenue appropriated for ISRP to annual costs toward ISRP and shows that the program is 102% funded through fiscal year 26 and 124% funded through fiscal year 2028.
6. **Fund Sources - Article 4-202.1(j)(1)(i)4: Any sources of funds that will be utilized by the county or municipality to meet the requirements of its National Pollutant Discharge Elimination System Phase I Municipal Separate Storm Sewer System Permit**
 - a. This table lists the funding sources supporting the MS4 program based on approved budgets for each fiscal year. Approximately 75% to 100% of the funds appropriated between fiscal years 2024 and 2029 go toward the ISRP.
7. **Best Management Practice (BMP) Codes**
 - a. This table provides a list of BMP codes, descriptions, and classes used in the Completed Actions and All Actions tables. BMPs include tree planting, construction of new structural BMPs, retrofitting existing structural BMPs, construction of environmental site design (ESD) BMPs, street sweeping, inlet cleaning, septic system upgrades, septic pump-outs, septic connections to the sanitary sewer system, outfall stabilizations, and stream restoration, where appropriate.

Howard County continues to implement the numerous programs required by the MS4 permit and is on-track toward meeting the ISRP. Note that some BMPs projected to be complete in fiscal years beyond 2024 may extend into later fiscal years. Also note that, even after meeting the ISRP, Howard County is required to implement additional restoration BMPs to meet the additional restoration requirements in MS4 Permit associated with local and Chesapeake Bay Total Maximum Daily Loads (TMDLs). These TMDLs require reductions in pollutants including nitrogen, phosphorus, sediment, bacteria, and polychlorinated biphenyl (PCB). As presented in the *FY24 Countywide TMDL Stormwater Implementation Plan*, meeting these TMDLs is projected to cost approximately \$171,750,000 over the next 31 years. In addition, Howard County remains responsible for and must maintain and repair existing BMPs for public safety and continued stormwater management. Most stormwater BMPs provide some level of pollutant removal and impervious surface restoration credit, and these credits are being tracked against the ISRP and TMDL requirements accordingly.

The County looks forward to continuing its successful water quality restoration program, continues to look for innovative ways to meet water quality restoration challenges, and strives to build partnerships with the community to improve local water quality and restore the Chesapeake Bay.
