1 **WHEREAS**, a seven member Compensation Review Commission is established and is  
2 empowered to set compensation and allowances to be paid the members of the County  
3 Council pursuant to the authority of Article 25A, Section 5(AA) of the Annotated Code of  
4 Maryland and Section 202(d) of the Howard County Charter and Title 5. County Council  
5 Subtitle 1. Compensation Review Commission of the Howard County Code; and

7 **WHEREAS**, pursuant to Section 302(e) of the Howard County Charter, the Compensation  
8 Review Commission shall review the County Executive’s compensation and allowances  
9 and make recommendations to the County Council regarding same.

38 The Commission shall elect from its members a chairperson, a vice chairperson and such

1 other officers as it shall deem appropriate.

2

3 **AND BE IT FURTHER RESOLVED** that, not later than December 16, 2013, the  
4 Commission shall submit by resolution to the County Council its recommendations of  
5 compensation and allowances for the County Executive and County Council to be elected  
6 in November 2014.

8 **AND BE IT FURTHER RESOLVED** the Commission may recommend an increase or  
9 decrease in the compensation and allowances paid to the County Executive and members  
10 of the County Council but in no event may compensation be less than that provided in the  
11 Howard County Charter.

13 **AND BE IT FURTHER RESOLVED** that the Commission shall hold public hearings  
14 which shall be advertised for two successive weeks in a newspaper of general circulation in  
15 Howard County, and notice of all meetings, public hearings and work sessions of the  
16 Commission shall also be posted on the County Council bulletin board and website at least  
17 two weeks in advance of such sessions.

19 **AND BE IT FURTHER RESOLVED** that the Commission shall terminate and cease to  
20 function on April 30, 2014.
