To whom it may concern,

I am a resident of Howard county and father of 2 children currently attending Marriotts Ridge High School that partake in school athletic teams. It is to my great dismay to see that the current proposed budget for FY26 does not include any additional funding for hiring full-time athletic trainers at all high schools.

As I understand it, the county has only budgeted funding for 7 contracted, part-time trainers to cover all 13 high schools, resulting in an average of a trainer on school grounds only 1-2 times a week for an hour at a time. This is woefully inadequate coverage considering the number of teams holding practice/games/events any given day.

I recently came across an article in the Baltimore Sun about parents whose child suffered a cardiac arrest during a practice that could not receive medical attention due to lack of qualified medical personnel on site and now that child is in a vegetative state likely for life. I CANNOT stress strongly enough the importance of doing the MINIMUM and staffing at least 1 full-time athletic trainer dedicated to each high school that can build familiarity with the school's student athletes and faculty, and help to certify other faculty members/coaches in being able to administer first aid. A contracted trainer spending a maximum of 1-2 hours on site a week is simply not enough except to cover the bare legal minimums.

For a county that budgets well over \$1 BILLION dollars a year for education, it is rather mind-blowing that the county can't find money to hire full-time trainers that would barely amount to 1 tenth of 1 percent of the overall budget. Staffing each high school with a full-time athletic trainer is literally a rounding error!

I urge the Superintendent, the Board of Education, the County Executive, and the County Council to please invest in the safety of our children and provide basic coverage for all our students. How many more children like the child from Hammond High School that is now a quadriplegic in a vegetative state need to suffer before the county finds it is worth spending a tiny fraction of money to get full-time trainers

in each high school, a tragedy that could have been prevented if a trainer was on site at the time of the incident? This issue cannot keep getting pushed off to "future budget years".

Given how we are contracted, many of the athletic trainers would love to be speaking up at the meetings but we feel we are in a hard place given the fact that we work for Athletico, the company whose services are contracted out to. We have been listening in on the Public Forum Board Meetings and the Board of Ed virtual working sessions to see how the topic of Athletic Trainer is being addressed. Most people have no idea what challenges we face, what it is we exactly do and or understand the real impact that athletic trainers make when it comes to high school athletics. Everything that you have been hearing from the student-athletes and parents is completely accurate when it comes to athletic trainers. However, you will never be able to have a true outline of the athletic trainer situation in Howard County unless you speak to the source directly or physically see it for yourself. Obviously the Council ultimately approves the Board of Educations budget, so before you choose to leave hiring athletic trainers from next year's budget please ask yourself if you have all the information needed to make an appropriate decision. If you would like to speak directly from the athletic trainers all you have to do is ask.

Our children's lives are worth the extra \$500k or so that would be needed to ensure their safety while partaking in the athletic programs they love via full-time athletic trainers. Thank you.

To whom it may concern,

I am a resident of Howard county and father of 2 children currently attending Marriotts Ridge High School that partake in school athletic teams. It is to my great dismay to see that the current proposed budget for FY26 does not include any additional funding for hiring full-time athletic trainers at all high schools.

As I understand it, the county has only budgeted funding for 7 contracted, part-time trainers to cover all 13 high schools, resulting in an average of a trainer on school grounds only 1-2 times a week for an hour at a time. This is woefully inadequate coverage considering the number of teams holding practice/games/events any given day.

I recently came across an article in the Baltimore Sun about parents whose child suffered a cardiac arrest during a practice that could not receive medical attention due to lack of qualified medical personnel on site and now that child is in a vegetative state likely for life. I CANNOT stress strongly enough the importance of doing the MINIMUM and staffing at least 1 full-time athletic trainer dedicated to each high school that can build familiarity with the school's student athletes and faculty, and help to certify other faculty members/coaches in being able to administer first aid. A contracted trainer spending a maximum of 1-2 hours on site a week is simply not enough except to cover the bare legal minimums.

For a county that budgets well over \$1 BILLION dollars a year for education, it is rather mind-blowing that the county can't find money to hire full-time trainers that would barely amount to 1 tenth of 1 percent of the overall budget. Staffing each high school with a full-time athletic trainer is literally a rounding error!

I urge the Superintendent, the Board of Education, the County Executive, and the County Council to please invest in the safety of our children and provide basic coverage for all our students. How many more children like the child from Hammond High School that is now a quadriplegic in a vegetative state need to suffer before the county finds it is worth spending a tiny fraction of money to get full-time trainers in each high school, a tragedy that could have been prevented if a trainer was on site at the time of the incident? This issue cannot keep getting pushed off to "future budget years".

Dear Members of the Howard County Council,

During the Board of Education budget sessions, they heard from many student-athletes about hiring Athletic Trainers directly through the county. I want to echo their concerns and express my strong support for hiring athletic trainers directly through the Howard County Public School System (HCPSS). While I understand the constraints of the current budget, our student-athletes, coaches, and school communities are being underserved by the lack of dedicated athletic trainers at practices and games.

Every school in our system has a Certified Nursing Assistant (CNA) or Registered Nurse (RN) during the school day to provide medical care—why should it be any different for student-athletes after school? Athletic trainers are essential not only for sports teams but also for coaches, spectators, the marching band, dance teams, clubs, and any other after-school activities that may require medical assistance.

Beyond orthopedic injuries, HCPSS has several student-athletes with serious medical conditions such as diabetes, sickle cell disease, and postural orthostatic tachycardia syndrome (POTS), just to name a few. In emergencies, seconds matter. How can a coach, with only a 15-hour training course, be expected to handle these situations? Calling 911 can take 10-15 minutes—precious time wasted when a certified athletic trainer could immediately assess, stabilize, and triage the athlete, coach, or spectator until more advanced life-saving measures arrive.

## The Benefits of Directly Hiring Athletic Trainers

Hiring athletic trainers as full-time employees of HCPSS, rather than relying on contracted services, provides numerous benefits:

- Consistency & Availability: Direct-hire ATs are fully integrated into the school community, providing stable and consistent care instead of rotating through different schools or being subject to staffing shortages from an outside company.
- Improved Communication & Coordination: ATs who are school employees can better collaborate with teachers, administrators, and coaches, ensuring a higher standard of care for student-athletes.
- Stronger Emergency Preparedness: Having an AT who knows the specific needs of each school, its facilities, and its students allows for faster, more effective responses to medical emergencies.
- Retention & Investment in Student Safety: Contracted ATs may leave for better opportunities, creating gaps in coverage. Direct hires are more likely to stay, build relationships with students, and contribute to long-term athlete health and safety. In other counties that have transitioned to direct hire, they do not have the staffing shortages Howard County has had.

In a one billion dollar education budget, it would cost an additional one million dollars to add Athletic Trainers. That is only 0.1% of the overall requested budget. This is a small price to pay for an increase in the safety and wellbeing of our student-athletes.

I have been a coach in this county for 16 years and have seen the benefits of having full time athletic trainers and the difficulties when we have not had one. There have been times that I have been the only coach at a practice or game and have needed to attempt to provide medical care or screening while also managing the rest of the team. Ensuring the safety and well-being of our student-athletes should be a priority. I urge you to take action in securing full-time, direct-hire athletic trainers for all HCPSS schools.
