  separated and unaccompanied children and their families.
- Support Legal Services Team Management and the Deputy Director with project management tasks, including reporting, and funder and media relations.
- On call travel to emergency intake sites and detention centers such as Fort Bliss, Tornillo and Port Isabel Detention Center in Texas.
- Undergone Hostile Environment Awareness Training (HEAT).
