To make hope possible rather than despair convincing.

#### COMMENTARY

In 1981 I discovered my son was involved with various substances. This began a twenty-two year journey of learning about addiction and fighting to save his life. When Jim died in 2003 at age 35, my brother Bill had also died. Bill's life ended when he was murdered by a friend tweaking out on crystal meth. In 2010, my niece Amanda ended her life six weeks after completing a rapid detox for her heroin addiction. Then November 2017, my brother Tom died of an overdose after years of managing his disease. The lives and deaths of these family members provide me with experience, wisdom and compassion for those who suffer this disease and all who love them.

By 2003, I had given up any hope that this disease would ever be respected, that treatment would become as available to those who suffer it as those who suffer from other life-threatening diseases such as cancer. Angry at how my son, my brothers, niece and I had been treated I turned from looking for treatment to learning about the history of addiction, medical research, national laws, criminal justice system and anything else related to this disease. Soon enough I was giving presentations to other parents whose children either had died or were struggling to stay alive. Over time I've met thousands of parents, grandparents, siblings, spouses and other loved ones struggling in the same way.

Today I divide my time between supporting those who have lost loved ones to SUD and working to eliminate the stigma and to bring hope through needed changes to systems of prevention, treatment, insurance, after care, laws on the local, state and national level. Finding grief support within The Compassionate Friends, I moderate two Facebook pages with over 6,000 parents, grandparents and siblings who have lost loved ones to this disease. I serve as a subject expert insuring these families are not marginalized in their grief due to stigma.

My decades of work and skills as a senior executive in academia and corporate organizations bring together my passion for saving lives and providing hope. As a long time educator within corporate and university settings my public speaking skills are well honed. To collaborate with others to bring change and hope to the State of Maryland is an honor.
