Short Title: Use of Excess Surplus Revenue – up to \$14,500,000 – FY26 Operating Budget of the Board of Education- Emergency Act.

Title: AN ACT to modify the restriction on the use of excess surplus revenue pursuant to Section 615B of the Howard County Charter in order to use excess surplus revenue from prior years to further support the Operating Budget request of the Board of Education in the Fiscal Year 2026 budget; providing that this act shall be temporary and shall expire by June 30, 2026; and declaring that this Act is an Emergency Bill necessary to meet an immediate emergency affecting public health, safety or welfare.

1	WHEREAS, the County Executive has prepared the Annual Budget and Appropriation
2	Ordinance of Howard County, Fiscal Year 2026 that contains the capital and operating budget
3	for the fiscal year beginning July 1, 2025 and ending June 30, 2026 (FY26 Budget); and
4	
5	WHEREAS, the FY26 Budget is pending in Council Bill No. 36-2025; and
6	
7	WHEREAS, the FY26 Budget has been developed under conditions of great uncertainty
8	that have been amplified by major workforce changes at the federal level and funding changes at
9	the state level, including cost shifts of approximately \$8 million to Howard County Government
10	from the State in FY26; and
11	
12	WHEREAS, the Howard County Public School System (HCPSS) is facing significant
13	funding needs in the FY26 budget related to employee compensation, special education,
14	transportation, fixed costs, and State mandates including implementation of the Blueprint for
15	Maryland's Future; and
16	
17	WHEREAS, in his proposed FY26 Budget, the County Executive proposed an increase
18	of \$39 million in direct recurring County funding to support the Howard County Public School
19	System (HCPSS), reflecting a 5.1% increase and totaling \$800 million in County funding
20	proposed to HCPSS in FY26; and
21	
22	WHEREAS, the County Executive proposed an additional \$6.7 million in County
23	funding to cover HCPSS pension liabilities in the FY26 Budget, a cost passed from the State to
24	the County, bringing the total increase in County investment to \$45.7 million for HCPSS
25	expenses in the proposed FY26 Budget, which reflects 64% of all new revenue growth; and
26	
27	WHEREAS, the Board of Education and Superintendent have identified that additional
28	funds are needed above the County increase of \$45.7 million to avoid reductions in staff and
29	impacts to core educational services in the FY26 Budget; and

to allow the use of excess surplus revenue from prior fiscal years in the amount of up to 1 \$14,500,000 to further support the County's portion of the Fiscal Year 2026 Operating Budget 2 3 request of the Board of Education. 4 Section 2. And Be It Further Enacted by the County Council of Howard County, Maryland 5 that, this modification is temporary in nature in that it only applies to the Fiscal Year 2026 6 budget, and at the end of Fiscal Year 2026, this Act, with no further action required by the 7 County Council, shall be abrogated and of no further force and effect. 8 9 Section 3. And Be It Further Enacted by the County Council of Howard County, Maryland that 10 this Act is adopted as an emergency measure to address an immediate emergency affecting 11 public health, safety, or welfare and having been passed by two-thirds of its members, this Act 12 shall be effective immediately upon its enactment. 13

1	WHEREAS, in order to avoid reductions in start and impacts to core educational
2	services, the County Executive intends to further support the County's portion of the Board of
3	Education's Operating Budget request; and
4	
5	WHEREAS, for Fiscal Year 2026, only, the County has determined that excess surplus
6	revenue from prior fiscal years in the amount of up to \$14,500,000 is necessary to further support
7	the Fiscal Year 2026 Operating Budget request of the Board of Education; and
8	
9	WHEREAS, pursuant to Section 615B of the Howard County Charter, the use of excess
10	surplus revenue is restricted to (1) fund capital projects, (2) reduce existing County debt; and/or
11	(3) fund appropriations in the current expense budget for capital outlay and for non-recurring
12	expenses; and
13	
14	WHEREAS, Section 615B also provides that the restriction on the use of excess surplus
15	may be modified by an ordinance passed by an affirmative vote of 2/3 of the members of the
16	County Council; and
17	
18	WHEREAS, the County wishes to temporarily modify the restriction on the use of
19	excess surplus revenue to further support the Fiscal Year 2026 Operating Budget request of the
20	Board of Education; and
21	
22	WHEREAS, because there may be reductions in staff and impacts to core educational
23	services, pursuant to Section 209(d) of the Howard County Charter, this Emergency Bill is
24	necessary to meet an immediate emergency affecting the public health, safety, and welfare of the
25	County.

Dear Chairperson Walsh and Members of the County Council,

Thank you for your continued partnership as we work through the Fiscal Year 2026 (FY26) Operating Budget process for Howard County. Today, I have submitted emergency budget legislation to the Howard County Council to direct up to \$14.5 million in one-time funding from the County's excess surplus revenue toward the Howard County Public School System (HCPSS) Operating Budget. Pursuant to Section 208 of the County Charter, I am respectfully calling the Howard County Council into legislative session on or before May 14, 2025, for the purpose of introducing the emergency legislation to modify County Charter Section 615B to provide additional funding to HCPSS.

This emergency budget legislation will authorize Howard County to draw upon one-time funding in the County's excess surplus revenue to direct toward the FY26 school budget, providing critical resources for the school system to address core staffing and programming needs in the year ahead.

As you are aware, our proposed FY26 Operating Budget provides a historic \$800 million in County funding to HCPSS, contributing to a total HCPSS budget of approximately \$1.2 billion when combined with State and other funding sources. Our proposed budget reflects a 5.1% increase of \$39 million in new recurring county funding for HCPSS, exceeding the state-mandated Maintenance of Effort by approximately \$39.3 million. Furthermore, we are allocating an additional \$6.7 million to educator pension liabilities, a new cost passed on to Howard County from the State this year. In total, we proposed \$45.7 million in new revenue for HCPSS expenses in our budget, representing approximately 64% of all new General Fund revenue growth in FY26.

Despite this record level of investment during a year of great uncertainty at the State and Federal level, HCPSS continues to experience severe budget challenges. During their May 5, 2025, presentation to the Council, HCPSS identified outstanding funding needs of approximately \$29.2 million in order to maintain core services without making reductions or adjustments to programs and staffing. Subsequently, on May 8, 2025, we sent a letter to the Board of Education identifying three strategies to generate savings and additional revenues within the HCPSS Operating Budget.

Our emergency budget legislation would authorize Howard County Government to spend one-time funds from the County's excess surplus revenue on recurring HCPSS operating expenses in the FY26 Operating Budget. Per the County Charter, one-time funding is restricted to spending on one-time expenses, such as the infrastructure projects in the Capital Budget, to avoid using one-time money on on-going expenditures that will stay in the base budget in future years. However, Section 615B of the County Charter permits the County Executive and the County Council to modify the restriction on the use of one-time funds through Council legislation.

This emergency authority has only been invoked once in the last two decades for the operating budget, when the County directed \$7.5 million in one-time funds to cover operating expenses during the COVID-19 pandemic. This underscores the significance of this proposed budget action, which is intended to ensure HCPSS can meet core services in the upcoming year.

This week, we will submit a budget amendment appropriating \$14.5 million from the County's excess surplus revenue to the HCPSS Operating Budget. This excess surplus revenue will be drawn from the County's Policy Reserve, which we fully implemented in FY21. Our Policy Reserve sets aside 3% of the budget on top of the Rainy Day Fund as a fiscal strategy to prepare for emergencies and unforeseen fiscal challenges that may arise. Coupled with internal HCPSS savings, our proposal to direct \$14.5 million in one-time County funds is intended to help meet the \$29.2 million funding threshold identified by HCPSS to avoid program and staffing reductions.

We do not take this action lightly. The use of one-time funds to support operating expenses will impact our future FY27 Operating Budget, as this funding will be built into the Operating Budget base and potentially eat into any new revenues realized in our FY27 Operating Budget. However, we believe that this is the most prudent and responsible approach to supporting the FY26 HCPSS budget without making even deeper cuts to core services, operations, and positions supported directly by Howard County Government.

Following the introduction of this emergency legislation, we respectfully request that the Council schedule this legislation for public testimony during your upcoming Legislative Public Hearing on May 19, 2025. Additionally, we request that this emergency legislation be scheduled for a vote at your upcoming May 21, 2025, legislative session, before the Council takes final action on the FY26 Budget.

Thank you for your partnership as we work together to finalize the FY26 Budget and ensure that Howard County remains the very best place to live, work, play, grow, and thrive for all.
