11	(a) Number of Members. The Board shall have a minimum of [[20]]21 members and a maximum
12	of [[27]]28 members.
13	(b) Apportionment of Representation. As practicable, the Board shall consist of a majority
14	private sector representation and a minority public sector representation.
15	(c) Method of Appointment. Each appointed member shall be appointed by the County Executive
16	and confirmed by the County Council.
17	(d) Qualifications of Members:
18	(1) All members shall either reside or work in Howard County.
19	(2) As practicable, the Board shall reflect the gender, geographic, ethnic, and racial makeup
20	of the County.
21	(3) Ex-officio members from the public sector shall include the following:
22	(i) The Director of the Department of Social Services, or the Director's designee;
23	(ii) The Director of the Department of Community Resources and Services, or the
24	Director's designee;
25	(iii)The Director of the Howard County Health Department, or the Director's designee;
26	(iv) The Director of the Department of Housing and Community Development or the
27	Director's designee;
28	(v) The Director of the Department of Corrections, or the Director's designee;
29	(vi)The Administrator of the Office of Workforce Development, or the Administrator's
30	designee;
31	(vii) The President of Howard Community College, or the President's designee;

1	(viii) The Superintendent of the Howard County Public School System, or the
2	Superintendent's designee; [[and]]
3	(ix)The Chairperson of the Howard County Housing Commission or the Chairperson's
4	Designee[[.]]; AND
5	(X) THE ADMINISTRATOR OF THE OFFICE OF CONSUMER PROTECTION OR THE
6	Administrator's designee.
7	(4) Ex-officio members from the public sector may include:
8	(i) The Chief of the Department of Police, or the Chief's designee; and
9	(ii) The Director of the Department of Planning and Zoning, or the Director's designee.
10	(5) Appointed members from the private sector shall include:
11	(i) A representative from the Community Action Council or any other Federally
12	designated anti-poverty agency;
13	(ii) A representative from grassroots or any other homeless shelter serving both
14	individuals and families;
15	(iii)A representative from Bridges to Housing Stability or any other provider of family
16	stabilization services;
17	(iv)A representative from the Association of Community Services or any other network
18	of human services providers and advocates focused on serving families in Howard
19	County;
20	(v) At least one individual who has used the services of emergency, transitional, or
21	subsidized housing;
22	(vi)At least one individual who has received cash benefits, services, or both, to support
23	their transition to stable employment;
24	(vii) A representative of a Howard County business that provides entry and midlevel
25	employment opportunities;
26	(viii) A representative of the Howard County Chamber of Commerce or any other
27	organization whose purpose is to facilitate the success of businesses;
28	(ix)A representative of a faith-based organization;
29	(x) An individual or representative of a business that provides financial services; and
30	(xi)A representative of an organization that provides, or advocates for, transportation
31	services.

1	(6) Appointed members from the private sector may include other community members or
2	representatives from nonprofit organizations, for-profit organizations, or faith-based
3	organizations that:
4	(i) Provide crisis intervention services;
5	(ii) Support the financial stability of individuals and families;
6	(iii)Advocate for the basic needs of County residents; or
7	(iv)Represent the needs of children and families, seniors, or people with mental or
8	physical disabilities.

10	Section 2. And Be It Further Enacted by the County Council of Howard County, Maryland,
11	that this Act shall become effective 61 days after its enactment.
