1           **WHEREAS**, Section 907 of the Howard County Charter requires the County Council of  
2   Howard County to establish a Citizens' Election Fund Commission consisting of five County  
3   residents appointed by the Council and two County residents appointed by the County Executive;  
4   and

6           **WHEREAS**, Section 10.310 of the County Code creates the Commission and  
7   provides for the qualifications, terms, and officers of the Commission; and

9           **WHEREAS**, the Commission's purpose is to calculate, not later than 180 days prior to  
10   the end of the fiscal year, the total amount estimated for the fall election cycle and the amount to  
11   be included in the current expense budget for the ensuing fiscal year to fully fund the Citizens'  
12   Election Fund System; and

14           **WHEREAS**, Section 10.310 of the County Code further requires that each nominee shall  
15   be confirmed by a separate Resolution of the County Council; and

17           **WHEREAS**, the current term of each member expired on May 1, 2025, and the current  
18   members are serving until reappointed, or a successor is appointed; there is an immediate need  
19   for the County Council to confirm each nominee;

21           **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,  
22   Maryland this \_\_\_\_\_ day of \_\_\_\_\_, 2025 that the representative of District 3 on the  
23   Citizens' Election Fund Commission is Matt Dellinger, Columbia, MD, to serve a term  
24   beginning upon passage of this resolution and ending on April 30, 2029.
