Dear County Council,

I am writing to strongly advocate against cuts to elementary GT teachers. Please fund the HCPSS operating budget so that these cuts will not happen.

As a pediatrician, I believe all children are gifted. I think renaming gifted and talented (GT) programs in the state to "accelerated opportunities" or some other more neutral term would go a long way to improving the unnecessarily polarized discourse around supporting the needs of accelerated learners. Unfortunately, as it stands, I frequently hear derisive comments made toward GT offerings, particularly at the elementary school level. These comments occur in public discourse, even in places where we would expect mutual respect toward all types of learners.

From my work with children and from discussions with parents around the county, children whose educational needs are not met become disengaged and disruptive. Last year, I saw this in my own 4th grader who became very disengaged in his English Language Arts class that is taught with children who have not yet mastered on-grade level reading when he was reading chapter books like Charlotte's Web in kindergarten. This disengagement pulled the teacher's attention from other students as she reached out to me because of her concerns. Unfortunately, this disengagement has continued into the fifth grade where GT math, GT Curriculum extension units, and GT seminars are the bright spots in his year. This disengagement has been so severe that my principal personally called me this month to check in when she saw that my child's behavior was changing. GT teachers at the elementary school level provide some of the only opportunities that accelerated learners have to engage with material at their level. When discussing my child with his GT math teacher, his level of engagement and respect in class is superb. When children are appropriately challenged, their engagement thrives.

Similarly, a parent of a 3rd grader confided to me that her son is frequently sent to the principal's office because he is disruptive in ELA, a class he feels like does not teach him new material. These children are not alone -- I hear similar stories from children and parents around the county.. Third, fourth, and fifth grade students have few opportunities to engage academically at an advanced level with the exception of their experiences with their GT teachers. Please fund them.

Having GT teachers in elementary school is positive for all children because it:

- 1) Increases the number of total teachers available to children in elementary school. Children who are not pulled out for GT opportunities, have an increased teacher to student ratio in their classes.
- 2) Prevents disengagement and disruptions. When children are taught at their level, their minds are engaged and they naturally diminish disruptive behaviors.

3) Promotes the social emotional development for children who are accelerated learners. Children feel disrespected and feel like their time is wasted when they are required to attend school but are forced to listen to material that is too basic for their level of understanding.

Thank you for reaching out to the Maryland State Board of Education to share your thoughts regarding our state's proposed math policy. We truly appreciate your engagement and dedication to the success of our students. Here is the most up-to-date version of the policy, for your convenience.


Core to this policy is the expansion of opportunities for accelerated math coursework for students in any grade. This policy prioritizes equitable access to acceleration opportunities, particularly for students who have been historically excluded, with structures in place to support their success. Therefore, we want to clarify that the math policy is not ending gifted and talented programming. On the contrary, the intent of this policy is to support and enhance more opportunities for acceleration in math for students from all backgrounds and in all districts across the state, including those who are already identified for and participating in gifted and talented programming.

To be clear, gifted and talented programs remain an important part of our educational framework, and the policy encourages the development of strategies that will support acceleration in a way that is both effective and equitable for all students. Note that additional revisions to the policy in the latest draft bring further clarity to this component of the instructional program. Our goal is to continue providing advanced learning opportunities while ensuring that all students have the tools and resources they need to succeed.

We appreciate your ongoing advocacy for our students and encourage you to continue sharing your thoughts as we move forward with these important initiatives. If you have any further questions or would like more information, please don't hesitate to reach out.

By investing in and preserving the GT program at the elementary level, we not only provide crucial opportunities for academic advancement and enrichment to students who need it most but also actively work towards leveling the playing field for all students, regardless of their background or circumstances. Cutting this program would only deepen the divide and further hinder the progress towards achieving equitable education for all. Therefore, I implore you to prioritize the needs of our underprivileged communities and maintain support for the elementary GT program.

Quote from an underprivileged fifth grade student after finding out about potential cuts, "My parents can't afford extra activities and they really can't afford learning summer camps. The only time I get to learn about something new and interesting is during Instructional Seminars."



I am writing as a concerned HCPSS parent and Howard County resident to urge you to add funding to the HCPSS FY26 Operating Budget. HCPSS needs *at least* an additional \$29.2 million to keep our current level of services. Without any additional funding, HCPSS students will face larger class sizes, reductions in programs, and the loss of valued teachers and staff -- all of which negatively impact the quality of our children's education and hurt our community.

Our public schools should be a top priority for the county, but this feels less true in recent years. Many families with older children talk about the glory days of HCPSS when we had smaller classes and GT and music programs that weren't in danger of being cut year after year.

Have you been inside a 3rd grade classroom with 29 kids with different needs and learning styles/abilities? If not, PLEASE DO before cutting paraeducators, cutting GT teachers, and increasing class sizes. It's chaos. The thought of increasing class sizes (through either the loss of GT teachers or allowance of class size increases) and reducing ES paraeducators (who are crucial to teachers being able to effectively teach that many children with different learning needs) seems unconscionable. The classes are already too big. In middle school, they can have 34 students in a classroom. How can we allow any more than that?

Additionally, elementary GT teachers and 3rd grade strings are very important to Howard County families. Last year families rallied to save these 2 vital programs and groups of teachers. The cost of saving these two programs is a fraction of the overall budget (\$4.7M), yet adds tremendous value to our schools, students, and community. Elementary GT teachers in schools reduce the student-to-teacher ratios in 4th-5th grade math and 3rd-5th grade science and social studies. This allows for more individualized instruction and benefits learners of all abilities. One 5th grade teacher told me her class size drops from 29 students to 18 students during GT math. This is a significant reduction in class size and benefits ALL students.

GT seminars, which are open to all students, promote critical thinking and introduce young learners to STEM, art, history, government, mythology, and literature topics they don't have time to fully explore during regular class time. This March my daughter in 2nd grade attended a GT seminar to build a leprechaun trap where she applied physics, math, and art. My daughter in 5th grade participated in a GT seminar on Greek mythology last year where she fell in love with Greek mythology. Since then, she has

been continuously checking out books from the public library on Greek mythology and learning as much as possible on this fascinating topic, all thanks to a GT seminar. Reducing GT teachers will result in the reduction or complete elimination of GT seminars.

Elementary GT teachers work with the solid majority of students, as 67% of HCPSS elementary students participate in GT programs. Early exposure to STEM is critical to fostering academic success. Many families do not have the resources to provide replacement GT and strings programs to students outside of school. Students in non-GT math classes will receive less support and less individualized attention as a result of these cuts. Cutting GT teachers hurts students of all abilities. As a county who prides itself on our education system, students of every ability level deserve the right to be challenged appropriately. These cuts undermine our values as a county.

I urge you to prioritize our students and schools by restoring the necessary funding to HCPSS. The children of Howard County are counting on you.

My children attend Waterloo Elementary School, I have a 1st grader and a 5th grader. I was also a student in the Howard County School system and I have seen firsthand (through my own experiences and through my children's experiences) how transformative the Gifted and Talented (GT) program has been.

From Oyster Restoration to Robotics, GT offerings at Waterloo and other schools provide enrichment that engages students in ways standard curriculum cannot.

However, the school system faces a projected funding gap of \$29.2 million. This shortfall has placed elementary GT teachers on the chopping block. Losing these educators means losing opportunities for students like mine, who have flourished in GT seminars.

At Waterloo Elementary alone, where my daughter attends, nearly 70% of students in grades 2-5 have participated in at least one GT seminar this year, demonstrating the critical role of enrichment programs in student success.

The FY 2026 budget allocates \$39.3 million in additional recurring funds to the school system, yet this amount is far short of the Board of Education's identified funding needs. 

I taught GT in Howard County for 18 years. I had taught third grade for many years before that and loved it, but realized I was not a good teacher for the slower learners. I had 3 reading groups and 2 math groups every day. I did not fully appreciate how the slower learners learned and felt I was cheating them. So when a GT position opened up, I jumped at the chance.

I learned "in the trenches" and it was hard, but it was valuable and I learned quickly.

I did at least 5 preps a day, with a different group, a different grade level every hour. I had conferences with parents who were challenging. I had at least every year who would send their nanny to conference because they were too busy. Those kids needed to be heard and convinced that they were important. That their questions deserved answers. I conferenced with parents who didn't speak English, but were too proud to ask for a translator. I had been counseled not to look them straight in the eyes because that was a sign of disrespect. They cared, but sitting and not understanding them was very stressful.

If you ever doubt for one minute the importance of a GT program, think about the GT students at Glenwood Middle

School who lost a friend and classmate, riding his bike without a helmet, and hit by a car. Their GT teacher helped them channel their grief into lobbying the state legislators to pass a bike helmet law. It passed, was the first one in the nation, was adopted by many more states, and has saved countless lives since then. Your Howard County GT teacher did that! Think about that for a minute! My students used classified ads to find a job and an apartment. They were given a checkbook. They went to the grocery store to list what they would buy for a week and how much money they'd need. They were given a budget and wrote checks every week to pay their bills. A regular classroom teacher can't teach those skills to the number and variety of students they have. These kids think faster, learn faster, get their work done faster and become bored. Then they get in trouble because they're bored. They need someone to appreciate their talents and give credence to their questions. GT teachers teach themhow to decide on a topic, find the sources they need, and go find the answers. I sometimes had to make the phone calls or write the letters because the sources wouldn't reply to children. I didn't want them to learn that they weren't important because they were young. They need to feel valued in the way they think and learn. My GT math students went outside every day for a week to record the colors of cars that passed by, compiled the data, and wrote to car manufacturers to see if their data matched theirs. They were so proud of themselves, and it was fun. They wouldn't get that in a regular classroom.

If you do not fund the GT Program you will be stifling these children and turning away their open and curious minds. Maybe the person who will find a cure for cancer or design an instrument to help get us to the moon and planets. With the demographics of Howard County, how can you deny these bright kids a chance?

I wrote letters. I walked to the capital in Annapolis and lobbied for funding for GT programs, because our kids are Special Ed too, just a different end of the spectrum. I wrote articles to try and turn around the notion that these kids don't need anything special, they're gonna get it anyway.

Don't kill all the potential that you have in your care. These kids deserve a chance to have their learning style validated, enforced, valued, and perpetuated. Every GT teacher has had the experience as I, has worked as hard, done the same challenging programs, and has sent their students on knowing that they have made a difference. Don 't take that away from the students entrusted to your "care and feeding".

I am a parent of two students at Deep Run Elementary School, as well as a member of the HCPSS GT Advisory Committee. I was incredibly dismayed to see the proposed cuts to GT teachers at the elementary level. At a Title 1 and Community School like Deep Run, this kind of cut will be incredibly detrimental to students who might otherwise not get this kind of educational opportunity. It is because we have two GT teachers that students are able to receive enhanced curriculum opportunities and additional instruction at all grade levels, not to mention the enrichment clubs, lunch bunches, and other offerings. The suggestion that the classroom teachers will take on this responsibility is ludicrous...it is something that will not happen. The reason we need GT staff is because classroom teachers are managing behavior and the significant number of students who are under grade level.

I work for BCPS as a school social worker in an elementary school and we do not have a GT program here. The school demographics are surprisingly similar to Deep Run, and yet our academics are significantly lower. A strong GT program is what makes HCPSS stand out as a district with the top academics in the state. This cut, if implemented, will result in lower test scores, less engaged students, and students who slip through the cracks academically. I know that funding in all school districts is complicated in today's federal landscape, but as someone extremely familiar with the elementary experience at a school in a more underprivileged area of the county, as well as the GT program, I urge you to look elsewhere and not make cuts to GT staff.

I am a concerned parent of a Howard county students and writing to express my deep concern regarding the proposed \$9 million budget reduction for the upcoming fiscal year, and its potential devastating impact on our students, particularly those enrolled in Gifted and Talented (GT) programs.

County Executive Ball, members of the Howard County Council, members of the Howard County Board of Education, and Superintendent Barnes:

I hope this letter finds you well. I am writing to express my serious concern and strong opposition to the proposed cuts to the district's Gifted and Talented (GT) program. As a parent of a student in the GT program at Hollifield Station Elementary School, I am shocked and dismayed that Howard County is even considering cutting funding for our brightest prospects.

These reductions signal a troubling disregard for the needs of advanced learners and risk undermining the academic potential of some of our district's most capable students. Gifted students have unique educational needs that cannot be met through general instruction alone. When these students are not appropriately challenged, the consequences are clear: disengagement, underachievement, and in some cases, behavioral issues born of frustration and boredom. Cutting GT programming undercuts the district's stated commitment to equity and excellence by denying students an environment in which they can grow at the pace and depth they require.

It is a mistake to assume that high-achieving students will "be fine" on their own. They will not -- without targeted resources, specialized instruction, and a peer group that pushes them intellectually. A truly equitable school system must serve the needs of all students, including those who are academically advanced. Dismantling GT programming in the name of equity is not reform; it is negligence.

I have met hundreds of people who have matriculated through Howard County's education system, and remain in the county with the hope that they can have their children enjoy the same high quality experience. With this in mind, I specifically moved to Howard County for the schools. But I am in absolute disbelief with the current state and situation of our education system.

Just yesterday, I attended Hollifield Station's annual Blacktop Party, where I learned that one of my son's GT classmates and their older two siblings will be transitioning out of the county's school systems to attend a private school. The parents indicated that they are fed up with the quality of the education and the persistent behavioral issues in the classrooms, and the inaction of school administration to remediate these issues promptly.

Based on personal experience, experiences of my friends and neighbors, and the current trends, I am questioning the quality of my decision to move to Howard County... and I am sure others will be doing the same. And I dearly hope the Board of Education and County leadership understand the long-term implications of even *considering* a proposal to cut GT funding.

Reducing or eliminating GT programs will have long-term consequences for our county's economic vitality. Strong public schools, especially those with robust advanced academic options, are a key factor in attracting and retaining families who prioritize education. Undermining these programs makes the district less attractive to high-skill professionals, business owners, and others who contribute significantly to the local tax base. As these families choose to relocate or enroll their children elsewhere, the overall quality of the students' peer groups will decline, negatively impacting the county's attractiveness, resulting in lowered property values and exposing the school system to further funding challenges by creating a negative feedback loop that harms all students, not just those in advanced tracks. This is not just an educational issue, it is a community sustainability issue.

I urge the Board to reconsider these cuts immediately and transparently. I also request a public accounting of the rationale, impact assessments, and what alternatives are being provided to ensure our most gifted students do not fall through the cracks. Families in this district deserve clarity, and our students deserve better.
