Dear Members of the Howard County Board of Education, Dr. Ball, Members of the Howard County Council, and Superintendent Barnes,

As a concerned member of the Howard County community, I am writing to share my input on the remaining \$9 million in budget reductions for the upcoming fiscal year. I am particularly concerned with the reduction in elementary GT offerings and the elimination of 3rd grade strings.

It is shocking to see so many proposed cuts, AGAIN, in the Howard County Public School System (HCPSS), particularly in a county ranked #7 in wealth in 2023 by US News and continual property tax increases. These cuts continue to be devastating to our entire county and detrimental to our county standards of education. I urge our elected officials to work together with HCPSS to help during this crisis and continue to solve the funding issues that seem to plague the system every year.

It is the duty of the school system to meet the needs of students, including those that struggle and those that excel. My child is a bright 4th grader who has had the wonderful opportunity to participate in the GT seminars, lower elementary CEUs and GT math with the school's GT educators. They are his favorite classes and keep him engaged in a way that his homeroom classes cannot always provide. To reduce funding in this area would be a detriment to children who are craving a deeper learning experience and wish to be challenged beyond the typical classroom experience.

For example, Northfield Elementary School has 2.5 G/T (Gifted and Talented) Teachers. A reduction to 1 G/T Teacher at NES would mean:

- The GT teacher would only teach 1 section of 5th grade math. The other section would be taught by a classroom teacher with no experience in grade 7 common core math standards.
- Other math classes in grades 3-5 will increase in size to accommodate no GT teacher.
- Curriculum extension units (CEU's) will be taught when possible by GT teacher and probably will need to be taught by a classroom teacher in grade 3.
- Primary Talent Development lessons in grades K-2 will need to be taught by the classroom teacher.

- Seminars will be eliminated. Seminars are student interest based and provide opportunities for ALL students to grow and learn about something new. Topics include: creative writing, STEM topics, Drones, 3D printing, math logic, and Unheard Perspectives.
- These cuts would create so much more work for the grade-level teachers, especially grades 3 5.

I also want to remind our elected officials that music education, in all of its forms, plays a pivotal role in shaping well-rounded individuals, fostering creativity, discipline, and teamwork. My child's involvement in 3rd grade strings not only enriched his academic experience but also contributed to his overall personal development. It is terrible that teacher's jobs are at risk because HCPSS does not see the value in giving our children the opportunity of learning a string instrument at this point in their education.

Research consistently highlights the positive impact of music education on academic performance. Students engaged in music often show improved cognitive skills, better concentration, and enhanced problem-solving abilities. These benefits extend beyond the music room and positively influence their academic achievements.

I understand the budgetary challenges that HCPSS faces, but I urge you to consider the invaluable contribution that smaller class sizes, challenging curriculum and music programs make to our students' lives. By investing more in HCPSS overall as a county, we are investing in the future leaders, artists, and innovators of our community.

I kindly request that you work together to solve any proposed cuts to teacher funding, GT programs and music funding and continue to support all programs that are considered well-managed and essential in our county.


Hello all,

First, I would like to say that I value what y'all do for HCPSS and that I know you are in a difficult position. I have watched so many meetings over the last few months and I have a greater understanding of the situation than I did before. I understand that each of you has different concerns and values, but I would like to share some of the ways that keeping the 12 music staff would benefit the areas of concern I've heard y'all talk about.

I have only taught in Title 1 schools in PGCPS & HCPSS and I can attest that music is for all students - it is not elitist or only for students whose families can afford private lessons, however if we destroy elementary music programs by eliminating 3rd grade strings, it could become that way. I have taught students who cannot speak any English but excel in music because it's our common and universal language. I have taught students who are twice exceptional (meaning they are G.T. And also receive Special Education services) they find the limitlessness of music exciting, their creativity blossoms in the possibilities music offers. I have also taught students who don't feel like they fit in at school, suffer from mental health issues and face challenges we all wish young people wouldn't have to deal with, but in 3<sup>rd</sup> grade they can become part of an ensemble that works together, where everyone is valued and important. Music is a safe way for us to express emotions that can otherwise be difficult to put into words, but with one song we can communicate those feelings to others. It unites and strengthens us. This community values music education and 3<sup>rd</sup> grade orchestra. I am attaching our concert videos here. The kids had so much fun, the 2<sup>nd</sup> graders are already excited for next year. I can't walk down the hall without them telling me what they want to play and what songs they want to learn next year! Music brings up test scores too, but it's important in its own right.

Please restore the music positions, GT, library paras, health assistance - we are the people who interact with children every day. We care about them our programs matter and should not be cut to create new positions that do not interact with students.

As a concerned member of the Howard County community, I am writing to share my input on the remaining \$9 million in budget reductions for the upcoming fiscal year. As a parent of a **Type 1 Diabetic**, I am extremely concerned with the cuts to Health Assistants. Northfield Elementary only has 1 health assistant and 1 floating nurse. If my daughter has a severe diabetic incident, who would be there for support? Is the expectation that teachers know how to administer Baqsimi (a nasal spray if she were to be unconscious)? Within our school alone, there is another Type 1 Diabetic, one student with epilepsy, one with hypoglycemia, and so many other student needs.

Secondly, as a family of two kids in GT programs, the cuts to GT would greatly impact their learning potentially. The GT program for math allows our students the opportunity to be pushed where other classes move at a slower pace. The expectation that a classroom teacher is to teach 7th grade common core math standards with no experience or training is alarming and not effective.

To achieve fiscal responsibility, I suggest considering reductions in the following areas: 3rd Grade strings, Paraeducators for Media, non-essential travel, and administrative/backoff jobs.

The cut proposed puts my daughters life at risk and if implemented, would require my family to find schooling that actually puts the health and welfare of children first.

- School health rooms are at the front lines of ensuring safety and readiness to learn. Health assistants provide not only clinical care, but also compassion, reassurance, and continuity in the lives of students many of whom face barriers to healthcare access outside of school. Personally, our child Josh has a life-threatening allergy to peanuts and other food allergies that can make him quite ill. We work closely with the school nurse and health assistant to ensure a care plan is in place, necessary medications are ready and available and not expired, and that in case of an emergency or need of an epi pen, Josh knows who to go to and how to communicate with the health room staff. This relationship is very important to us and many other families at Dunloggin whose children have chronic or acute illnesses.
- My son Josh benefited from a robust G/T program at Northfield Elementary when he went there. He was able to participate in G/T Math, curriculum extension units, and seminars. These classes were some of the most challenging and preparatory classes for middle school. I attribute his ability to adjust to the demanding G/T schedule in middle school to having had exposure to G/T classes and curriculum in elementary school. I strongly encourage the preservation of Elementary G/T positions so as to continue developing strong students and to prevent added work to grade-level teachers who are already struggling with large classes and heavy workloads.

We are all extremely concerned about cuts to our valuable teachers and programs. In recent communications, County Executive Ball assured the community that the school system had what they needed not to make any cuts to current staff and services. However, the Board of Education has announced the elimination of 51 elementary teaching positions. These cuts contradict your statement and raise serious concerns about transparency and communication between county leadership and the BOE.

Cutting teachers and programs harms our students. The community has made its stance clear: we **do not** support these cuts. Howard County Council,

I am writing to you as a deeply disappointed parent of a Jeffers Hill Elementary School student and as a gravely concerned community member.

The County Executive and County Council continue to fail the most vulnerable members of this community - its children. I, along with many other Howard County residents, engaged Dr. Ball and this Council several times during the fiscal year 2026 budget process to advocate for our students and our community. My councilmember. Mr. Jones, has yet to return a phone call or email I've left with his office in the past three years. The canned responses I receive from Mr. Thompson are inflated gaslighting at best. School and library funding comes from the same budget allocation, but the council continues to send the message that the county does not have enough funding for schools and puts on a facade that it is making hard decisions when, in reality, this council has approved use of \$143M to build an unnecessary Lakefront Library. Howard County Public School System (HCPSS) Board of Education asked for approximately \$30M above Dr. Ball's proposal this year and were told that there is simply not enough funding - this is patently false. This county has plenty of money. The problem is a County Executive and County Council that refuse to make ethical decisions.

Jeffers Hill Elementary School celebrated its fiftieth anniversary this year, and has never had a renovation. Our school is overcrowded, underfunded, and underserved. We are Title 1 eligible, but Howard County drew the line above us, so we do not benefit from Title 1 funding. This is unfair to every single child at our school. The children in this county need and deserve to see the gap closed between what HCPSS needs and what the County Executive proposes and the council approves in the county budget. Once again, you failed to do this. The County Executive's press releases say that this council allocated more funding to HCPSS with the FY26 budget than previous years and while this is technically true, it is not the whole truth. HCPSS has received a smaller percent of the county budget year-over-year for at least the past five years, and the amount received is simply not enough to maintain the current

school system, much less to provide for sufficient infrastructure, staff, and other resources to truly support our community.

Because the council unanimously approved a budget that funds luxuries such as new libraries and art centers over necessities such as a sufficient quantity of schools with enough space and staff to support our students, the Howard County Board of Education had no choice but to make impossible decisions for FY26. Last night, the Board of Education cut 102 positions across our schools. This includes 12 third-grade strings teachers, effectively eliminating third grade strings across the county; 39 gifted and talented teachers, effectively eliminating that program in elementary schools; 21 elementary school paraeducators that are the lifeblood of our schools; and 12 high school secretaries.

This will result in needless suffering for every child in HCPSS. Larger class sizes, less staff, staff that will be more overworked than ever, results in a diminished educational experience for every child in the school system. Staff will leave the county due to low morale and burnout, and HCPSS will be a shell of what it once was. I chose to raise my family in Howard County because of its public school system. The school system is the reason Howard County residents pay higher prices for homes and higher property taxes. With the school system put into voluntary decline by this council, the incentive for families to stay in Howard County is gone.

This council, specifically Mr. Jones, Ms. Rigby, and Mr. Yungman, consistently vote in favor of development and, as a result, overcrowd and degrade our schools. This council consistently does not give HCPSS the budget to hire more teachers and staff, build new schools, or even to keep up with deferred maintenance. This is deplorable and unacceptable.

Please do the right thing and fix the budget issues you've created with over development and no infrastructure support. Please stop making our children pay the price for poor decision making by adults. Fully fund HCPSS at the HCPSS Board of Education's budget request every year. Doing anything else is a direct attack on our children.

I will not vote for Mr. Jones at reelection and I will relentlessly advocate for all residents of this county to vote against all of you at reelection. You have completely failed our community.

I'm not writing this to get sympathy, but I would like to make a few points that seem to have been forgotten when the financial bottom line was prioritized.

As someone who believes in music and music education to reach ALL students, I was truly disheartened and disappointed by multiple statements heard throughout this process. No, not all students can learn to read music from an app, just as media literacy and empathy cannot be taught by an app. That conjecture was a statement to justify a vote and was used to ensure that the priority wasn't music education in this budget cycle. For those of us who are experts in our field, we know that students cannot learn content standards and authentic experiences from an app, or we wouldn't have public education and teachers.

The sentiment that ALL of our students who want to do music in third grade will just get private teachers/ lessons/ find another way is again, a justification for a decision and a gross misrepresentation of music education. There will be outliers, but you've created a wealth gap for music education in Howard County, a system that has publicly touted a focus on equity for several years. If you were to check the data for my current school population, you would see that no, recurring private lessons will not be feasible for most families in our community. This year alone, I loaned over 100 HCPSS-owned instruments to families who needed access to them to participate in instrumental music. In third grade alone, only three families out of forty-eight could provide their OWN instrument. You've now put forty-five families at a disadvantage because of their economic situation. Their children won't benefit from crucial fine motor skills practice, decoding, letter recognition, math connections, and a social-emotional connection with a trusted adult. Not to mention musically, they are another year behind those who can afford early private music lessons.

As someone who has worked in education for 18 years, who has taught at Title 1 and non-Title 1 schools, in this county and another, being at Stevens Forest in a Community School has been the highlight of my career. Our school has made leaps and bounds of progress in connecting with students, decreasing chronic absenteeism, and growth in math and reading, all a testament to the model and the implementation by my administration and our Community Schools Coordinator. We have pages of data to prove this. I volunteered my time to become well-versed in the Community Schools model and supported numerous evening events. In the mornings, I arrived early to help students practice when I didn't have bus duty; I had a bus duty that included, for the past seven years, being at a crosswalk greeting every student and family by name and building relationships. I was awarded a Bright Minds Grant to bring drumming, emotional regulation, and attendance up for third through fifth-grade students. Sadly, the program cannot continue without someone to facilitate it, because, due to the recent budget cuts, there will most likely not be a full-time instrumental music teacher at SFES next year. I teach students to play instruments in Spanish so that all students are reached, which I hope the next instrumental teacher(s) will be able to do, but I can't be certain. Our SFES kids are amazing, talented, and some of the best musicians I have ever taught, and no one can convince me otherwise.

Year after year, I have invited the School Board, County Council, County Executive, and Superintendent to witness our amazing musicians at our annual Spring Concert/ SpringFest, which grew from a necessity out of COVID precautions to the most well-attended SFES event. It now includes a community resource fair and access to community-focused resources, including our new and amazing Judy Center with a musical storytime throughout the concert. Not one person from these organizations has come to see the connections that we have made. Through music, alumni return to play or reconnect and other educators from our school and around the county voluntarily attend to help or to be a part of something magical. I understand that you were all busy debating the budget, but to not be aware of something so amazing, and to say that we don't have educators making connections or volunteering their time is a false and hurtful statement. To say that anyone can learn music, and that students can do it if their parents find another way outside HCPSS, is a straw man argument, meant to undermine the blood, sweat, and tears of our music teachers. To say that music in our community isn't a priority is a lack of awareness.

My late grandfather always said to treat those around you like you want to be treated, and to be honest, you have lost me. The way our passion, our jobs, and our desire to reach children through a different lens than the classroom teacher has been mocked, and reduced to being numbered to find out where we will be placed next year or how much can be saved if we are cut, is not the way anyone in the field of education wants to be perceived. You want authentic connections and the best for all students, but when you treat people with their own families, their own "stuff going on" like a number, that sends the opposite message. Reading and math coaches do a wonderful job, but their role is to support the teachers and not instruct and assist students every single day like media paraeducators, teacher's secretaries, music educators, or GT teachers.

Music will continue in Howard County, elementary media will continue without paraeducators, and high school front offices will function, but for many HCPSS students, they have lost an incredible opportunity to connect with adults who care about them through no fault of their own. This is my story of what I, as one employee, brought to my students, community, and school. I'm sure there are a plethora of these stories that seem to have been forgotten so that a bottom line could be reached.

#### **Dear Council Members:**

I am writing to encourage you to increase the budget provided to the Howard County Public School System so that cuts in current levels of services do not need to be made. I understand that difficult budget decisions must be made in the coming year, but the levels of cuts being considered do not support our students and teachers, nor represent the quality education programs that Howard County is known for. Please consider cuts to programs other than education in Howard County.

In particular, I ask you to strongly reconsider the decreased funding proposed for the Gifted and Talented program. As a parent of a current 3rd grader at Waterloo Elementary School, I have seen firsthand the impact of the G&T program on cultivating academic excellence and furthering active engagement among the student body. This year alone, my 3rd grader was able to able to hone engineering, writing and presentation skills through Safe Racer sponsored by the G&T program. Her team placed 1st in the school-wide competition, and it was a moment of pride for my daughter who appreciated the hard work they put in as a team to earn the top honors. In addition, my 3rd grader developed research and public speaking skills in another G&T class by selecting to learn about Mae Jameson, the first African-American female astronaut. These opportunities are important to cultivate early on among high achieving students in public schools so they can be on equal footing academically with students in private schools. Please reconsider fully funding the G&T program for HCPSS.

In addition, I am disappointed in the funding cuts being considered to the orchestra strings program in the 3rd grade. My daughter started learning violin from a wonderful, dedicated music teacher at Waterloo ES and will now begin private lessons to continue her love for music. Please do not take away this opportunity from future 3rd graders like her younger brothers and those whose families may not be able to afford private lessons.

I urge you to reconsider the most recent funding cuts in support of our students, staff and nurses in HCPSS.
