1 **WHEREAS**, the Howard County Council is interested in promoting charitable donations
2 to nonprofit organizations in the County; and

4 **WHEREAS** Big Brothers Big Sisters of the Greater Chesapeake wishes to use
5 Community Investment Tax Credits to provide a continuum of services, including one-to-one
6 mentoring and enrichment experiences for children facing adversity and youth development
7 training for adults who are mentors or would like to become mentors; and

9 **WHEREAS**, Big Brothers Big Sisters of the Greater Chesapeake has applied to the
10 Department of Housing and Community Development of the State of Maryland for approval of
11 an allocation of tax credits for business entities and individuals that contribute to the
12 organization, under the Department's Community Investment Tax Credit Program; and

14 **WHEREAS**, the regulations of the Community Investment Tax Credit Program require
15 that all projects receiving tax credits receive support from the appropriate governing body of the
16 locality in which the project is situated.

18 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
19 Maryland, this 30th day of July, 2014, that it hereby endorses the
20 proposed financing to Big Brothers Big Sisters of the Greater Chesapeake.
