**A New Library and New Affordable  
Homes: Let's Make Them Happen**

On Monday, Nov. 17, the County Council will hold a public hearing on two measures that would add over 400 mixed-income homes in Downtown Columbia – while delivering a modern, accessible Central Branch Library to the Columbia Lakefront.

On the agenda:

- [Council Resolution 233](#) – Authorizes the County to acquire a Lakefront parcel from the Howard Hughes Corporation for the new Central Branch Library.
- [Council Bill 69](#) – Releases budget funds for planning and design of the new Library.

After the new Library opens, the current Central Branch site will be redeveloped as new mixed-income housing. The transactions would also include the transfer of a Howard Hughes-owned Merriweather parcel to the Howard County Housing Commission, for development of additional homes.

Together, these actions keep the Rouse vision alive – an affordable, equitable, and diverse Columbia – and advance the County’s commitment in 2017 to create 400+ affordable homes in Downtown.

Hello Council members,

During the work session held on the 2026 Capital Budget last April, the Council was clear that the logjam surrounding the new Central library had to be resolved as it was holding up a significant number of affordable housing plans in Downtown Columbia. The deadline was September 15, 2025. The county administration could not meet this date but now has a path to clear the logjam. Please vote in favor of CB 69 which removes the date deadline.

The need for affordable housing (MIHU and LIHU) in Howard County is only getting worse. CR 223 sets the series of steps that must be taken to move forward with the hundreds of units that the Howard County Housing Commission will need to build. It involves the purchase of the Lakefront site by Howard County. The Howard Research Development Corp will sell the Merriweather site to the county for zero dollars allowing the Commission to move forward with that development. Once the library is built, the central library site will also end up in the Housing Commission's portfolio. This represents something like 300 units of rental housing for our citizens.

The budget for the Central library (capital budget L0020) has 10 million in grants which should go a long way in the purchase price for this land which was appraised at 14 million.

We will then have four years to accumulate the funds for this library. I suggest that we look for grants and that the library start a capital campaign. This library will hold more than books – it will be a 21<sup>st</sup> century library with experiences, opportunities to utilize space and equipment for things like broadcasting, cooking, and community assembly.

I urge you to pass both bills.

Testimony on CR 233-2025 and CB 69-2025

Regarding: Authorizing the County to acquire a Lakefront parcel from the Howard Hughes Corporation for the new Central Branch Library and releasing budget funds for planning and design of the new Library.

Chairperson and Members of the Howard County Council,

Thank you for the opportunity to provide testimony in support of CR 233-2025 and CB 69-2025. I offer these remarks on behalf of The Arc of Howard County, a provider of community-based supports for people with intellectual and developmental disabilities (IDD) in Howard County.

This package matters because it treats learning, housing, and community vitality as linked goals rather than competing interests. By advancing a new, first-rate public library while also creating the framework for hundreds of new homes downtown, the legislation moves us toward a more inclusive and functional Columbia. The County committed in 2017 to adding more than 400 affordable homes in the Downtown area. CR 233 and CB 69 finally give us an implementation path that turns that commitment from an aspiration into something measurable and deliverable.

The land-use sequencing is efficient. The Lakefront acquisition makes the new library possible. Redevelopment of the current library site, combined with transferring the Merriweather parcel, opens up land that can actually support mixed-income housing at the scale this community needs. At a time when vacancy rates remain low and household formation outpaces our housing supply, policies that expand options for a range of incomes are necessary if we want Columbia to stay attainable for people with disabilities, teachers, Direct Support Professionals, first responders, young adults, and older residents.

This is fully consistent with the original Rouse vision: a community where people of different backgrounds and income levels can live, learn, and participate together. Passing CR 233 and CB 69 keeps Columbia moving in that direction.

I encourage approval of both measures and continued public transparency as the implementation proceeds. I appreciate your consideration.

**County Council Testimony re: Central Library at the Lakefront**  
**Marcy Leonard**  
**November 19, 2025**

Chair Walsh, Vice Chair Jones, and Members of the Howard County Council, my name is Marcy Leonard, and I appreciate the opportunity to speak with you this evening about the Central Branch of Howard County Library System, specifically CB69-2025 and CR223-2025.

I have lived within walking distance of the Central Branch since its opening in 1981, and I am a resident of Columbia

As an elementary school student, my most cherished memories are of visiting the library on Friday afternoons with my Mom and sister to get lost in the stacks, ask the children's librarians for recommendations, and then head to the mall for dinner (shout out to Jade Palace and Bun Penny).

As a middle and high school student, Central library was the place I did homework, studied for the SATs, and first used a computer to look up colleges.

As a social studies teacher at Wilde Lake High School, Central library was the first place where I directed students looking for research resources for class assignments.

As Principal at Wilde Lake and Atholton High Schools, Central library was our trusted partner to provide academic and technology resources for families who don't have consistent access to wifi or computers at home. Central library welcomes Wilde Lake's Multilingual Learners each year for a field trip to see all the resources available to students. Central library visits the Teen Parenting program at Wilde Lake monthly to share early childhood literacy strategies with our teen moms and provide board books to take home, so the children of children will be prepared for the Kindergarten Readiness Assessment.

Sadly, Central library no longer meets the needs of our community.

We cannot claim that Central is an accessible building because the frequency of elevator malfunctions means that community members with mobility issues cannot get to the resources on the second floor.



Spaces and amenities that our community takes for granted at our other branches, as they should, are non-existent at the Central branch, including no private study rooms, only a single meeting room for groups larger than 30 people, no dedicated teen center, no Makerspace, no STEM classrooms, no entrepreneurship incubator, no cafe' seating area, and a dearth of electric plugs and internet ports for individual laptop use.

Despite the brightness and cheer of the most dedicated and amazing staff members at Central, the building's furnishings, carpeting, HVAC, bathroom fixtures, and concrete walls are worn past their ability to be remedied. Central library lacks exterior windows to bring the light in and has no dedicated outside spaces for learning and play.

In my new role working with Howard County Library System, I have learned that the Central libraries in most library systems are the exemplars for learning, growth, and connection for their community. They provide multiple opportunities for literacy, entrepreneurship, connection, and access. We cannot begin to say that about our present Central library building.

What weighs heaviest on my heart about the present status of the Central branch is that it is not the first place that our young people think of when they are seeking third spaces outside of home and school. We know that the challenges our youth face are significant, and the library is the perfect place for them to find every resource they are seeking, at no cost to them. The fact that 3 young people lost their lives to gun violence just ½ mile away in the last 18 months is heartbreaking. Those are our kids; those were my kids. They deserve a space that is welcoming, accessible, and where they are not required to engage in a retail transaction in order to be in the space. They deserve a space to learn, grow, and connect.

Our next generation of Howard County community members deserve a Central library that meets the needs of the next 45 years, that will drive economic growth, and that they can come home to, with their children and grandchildren. Thank you for your support.

To the Howard County Council:

Thank you for the opportunity to provide testimony in support of County Resolution 223-2025. If approved, this resolution will serve two critical purposes: building a new Lakefront Library as a signature civic institution in downtown Columbia; and advancing new housing development that will boost availability of quality, stable homes that people can afford.

Where we live impacts our quality of life and how healthy we are – and we all want to live in vibrant neighborhoods full of opportunity. But for many Howard County residents, our community is becoming an increasingly unaffordable place to live – and our housing system is a major reason why.

This is not just anecdotal – it is backed up by data. Howard County renters pay among the highest rents in the state. Housing inventory has dropped while median home prices have skyrocketed. And according to a recent report from the Comptroller's office, people are leaving this region and moving out of state because the cost of living has outpaced incomes. In fact, Maryland lost a total of 2.3 million residents to other states between 2010-2023.

While the affordability crisis is affecting everyone, Hispanic and Black residents are twice as likely to be renters compared to White residents, and therefore much more likely to be cost burdened and have to make difficult decisions about whether to pay rent, buy groceries or afford healthcare in an already strained economy.

We, the undersigned organizations, want Howard County to be a place where quality, stable homes that people can afford are widely available. We should strive to build a future where all people can live in vibrant neighborhoods full of opportunity – and where all people are treated with dignity and have the opportunity to achieve good health and overall wellbeing.

This proposed plan to acquire land to build the new Library and redevelop the current Central Branch site is a step towards that future. This plan will ultimately provide for hundreds of mixed-income units that will support the working people of Howard County – our teachers, firefighters, police officers, hospital employees and more. People should be able to live where they work. Having a quality, stable place to live should be a pathway to economic stability and growth.

In addition, the Howard County Library System is a trusted and vital pillar of our community. The new Lakefront Library would be a major asset to the county, allowing for new programming and community space and resources. Along with these housing developments, strengthening this cultural institution in the heart of downtown Columbia will help to achieve an inclusive, connected community where everyone feels they belong; and where Howard County can continue to be a model for equitable and thriving communities.
