1           **WHEREAS**, Section 3-202 of the Health – General Article of the Annotated Code of  
2 Maryland and Section 12.107 of the Howard County Code authorize the Health Department to  
3 charge fees for certain food service facility activities that it regulates; and

5           **WHEREAS**, the Health Department has proposed to amend its Food Service Facility  
6 Regulations to include certain farmer’s market activity; and  
7

8           **WHEREAS**, accordingly, the Health Department has proposed to amend its Food  
9 Service Facility Fee Schedule in order to add certain farmer’s market licensing fees; and

11           **WHEREAS**, the Board of Health has reviewed and recommended the fees for the  
12 farmer’s market licenses; and

14           **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,  
15 Maryland this \_\_\_\_\_ day of \_\_\_\_\_, 2012, that it adopts the attached revised Food  
16 Service Facility Fee Schedule that includes fees for farmer’s market licenses; and

18           **BE IT FURTHER RESOLVED** that the Food Service Facility Fee Schedule shall be  
19 effective August 1, 2012 and shall continue in effect until changed or repealed by subsequent  
20 resolution of the County Council.

## FOOD SERVICE FACILITY FEE SCHEDULE

*These fees are adopted pursuant to Section 12.107 of the Howard County Code.*

Food Service Facility License	
High Priority	\$300
Medium Priority	\$250
Low Priority	\$75
Food Service Manager Certification	\$15
Temporary Food Service Facility	\$65
Mobile Food Vendor License	\$100
Seasonal Farmer's Market Producer Sampling License	\$90 per year (good for all farmers market locations)
On Farm-Food Service Facility Temporary License	\$30 per 30 consecutive day period (up to 2 renewals in a one-year period)
Non-Farm Temporary License	\$125 per season (April 1 to November 30)

### **Technology Fee**

In order to defray the cost of replacing the Environmental Health data management processing system for the Health Department, a technology surcharge is established and will be collected on all uncapped established fees. The amount of the technology surcharge is 10% of the approved fee rounded to the nearest dollar.
