3 County through the Department’s Maryland Economic Development Assistance Authority and
4 Fund (“MEDAAF”); and

7 potential for expanding or retaining employment opportunities within the County; and

9 **WHEREAS**, the County Executive and County Council have determined that it is in the
10 best interests of the citizens of the County that the Department provide the MEDAAF financial
11 assistance described in this Resolution; and

13 **WHEREAS**, in accordance with the provisions of Title 5, Subtitle 3 of the Economic
14 Development Article of the Annotated Code of Maryland, the Department requires that the
15 County approve a resolution endorsing the financial assistance being given by the Department
16 for the project described in this Resolution.

18 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
19 Maryland, this 29th day of October, 2014, that Howard County hereby endorses the
20 Department providing the MEDAAF financial assistance described below for the following
21 project:

- 22 • \$1,000,000 MEDAAF Conditional Loan for Coastal Acquisition, Inc. for:
- 23 1. The lease, construction, and improvement costs of a “to be built facility” located
24 at 9001 Whiskey Bottom Road, Laurel, Howard County; and
 - 25 2. The installation of machinery, equipment, furnishings, fixtures or leasehold
26 improvements in the company’s current location of 8704 Bollman Place, Savage,
27 Howard County, Maryland and at the ‘to be built’ facility located at 9001
28 Whiskey Bottom Road, Laurel, Howard County.
