Chairman Ball and members of the County Council:

My name is Grace Kubofcik. I have lived in Ellicott City since 1969. I have been a member of the Howard County Sierra Club since 1986. I have been a member of the Patapsco Greenway Board since 2009. My testimony is in support of Council Resolution 96 to designate a Patapsco Heritage Area in a portion of Howard County between Daniels and Elkridge.

Specifically by adopting Council Resolution 96, you, the County Council, adopt the proposed boundary of the Heritage Area in Howard County and the proposed Management Plan. I appreciate the Administration's support for the proposed Heritage Area boundary and Management Plan.

The Management Plan is a requirement of the State of Maryland Heritage Area Authority. The Management Plan first provides background, the vision, mission and goals for the proposed Heritage Area. The Plan documents the significance of the Patapsco Valley. It provides an interpretive framework and a very detailed description of the heritage, cultural, natural and recreational resources located in the proposed Heritage Area. The Plan also provides detail about community planning and maps for Howard and Baltimore Counties. This includes land uses, historic preservation plans and programs, green infrastructure and scenic resources and the Patapsco Valley State Park. The last two chapters of the Plan document the detailed action plans that the Heritage Area governing body, Patapsco Heritage Greenway, Inc. will have to strive to accomplish.

The State of Maryland Heritage Areas Authority is a 19 member independent body, under the Maryland Historic Trust, an agency of the Maryland Department of Planning. Members are: the State Historic Preservation Officer, Departments of Planning, Business and Economic Development, Housing and Community Development, Natural Resources, Transportation, and Maryland Higher Education, two representatives of the President of the Senate, two representative of the Speaker of the House, the Maryland Greenways Commission, the Maryland Tourism Development Board, Maryland Association of Counties, the Maryland Municipal League, two Governor appointees and two ex-officio, non voting members, the Department of Agriculture and State Department of Education. The Department of Natural Resources, a voting member of the Maryland Heritage Area Authority, will be on record regarding the certification of the Patapsco Heritage Area. The Authority is the entity that designates that the Patapsco Heritage Area is certified. It is also the entity that sets policy and oversight of the current 12 State Heritage Areas. It approves annually funding for the Areas and approves grants for community proposals that enhance Heritage Areas.

I attended all but one of the numerous public meetings the Patapsco Heritage Greenway has held regarding the Master Plan and its development. I had the honor to work with a small group of Board members and our consultants as we crafted the proposed Plan. Many community members and organizations asked us to consider enlarging the Heritage Area. The reality is, we are a non-profit volunteer board and what is proposed will be a major undertaking for us. We will have to hire staff to help.

The Patapsco River and all of its contributing streams descending down slopes and through meadows is our heritage. Individuals saw the potential of waterpower to move machines to grind and spin, to move goods to other villages, cities or Europe. They settled by the river. Individuals saw the earth and trees as valuable resources to construct homes, mills, businesses, and towns, a port, mine resources for ammunition and ballast. Individuals saw the need for roads and train tracks, viaducts and bridges to move products more efficiently and to travel and settle further west. Individuals abused the land, denuding slopes, allowing the river to be impacted and polluted. Individuals saw the need for responsibility and began to donate parcels of land that could be assembled and were created into the first Maryland State Park, Patapsco Valley State Park. All of this and much, much more is our heritage. But it started with the Patapsco River.

My answer to the Sierra Club's proposal to remove the Patapsco Valley State Park from the proposed Heritage Area is no. If you do that you rip out the spine of our heritage. Should we wait for the State Park to develop a Master Plan as the Sierra Club suggests. My answer is no. The Park has a 1981 Master Plan. It needs to be updated. We and we hope the Sierra Club will continue to press the Department of Natural Resources for that update. We also want to be sitting at the table, along with the Sierra Club and other interested parties giving input and direction to the Department of Natural Resources when they undertake a Master Plan revision.

It is false to assert that the Heritage Area Master Plan would control the use of land in the State Park. It is false to assert that the Master Plan would create development in the State Park. The State, not Howard or Baltimore County owns State Park land. In fact, in support of the environmental sensitivity of the Patapsco Valley the Counties have made land use decisions to minimize development on land adjacent to the park and valley. The Patapsco Heritage Greenway, Inc. has, while I have been on the Board, encouraged the purchase of land for open space or additions to the Park as well as supported Howard County Recreation and Parks in their land acquisition near or adjacent to the Park, a most recent example was two parcels along Landing Road.

The Patapsco Heritage Greenway, Inc. has a long record of protecting and enhancing the Patapsco Valley State Park's natural environment. We have volunteered and welcomed and encourage others to do clean up activity in the river and connecting streams, we have pulled invasive plants, we have provided education to elementary school students, we have mentored college students, worked with businesses who

wanted to help with cleanups sometimes with streams that run adjacent to their property. We have taught and supported a large contingent of stream captains. We have also supported the heritage of the Valley in the Park by creating interpretive signage and holding events like Daniel's Day to tell the story of mill town life.

During this yearlong process developing the Master Plan, we have encouraged and asked for comments and amendments. We have incorporated many of them. We wanted the larger community to be involved. We are committed, once certified, to establishing an Advisory Board to draw on the expertise of organizations, communities, business and government to enable us to be successful in our mission and legacy.

I ask for your favorable vote on CR 96-2014 for a Patapsco Heritage Area. Thank you.
