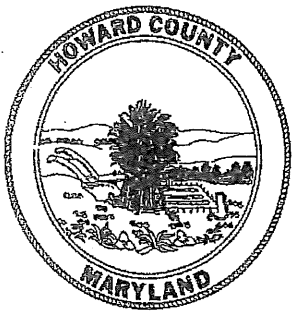
WHEREAS, Sections 6.326 and 12.202 of the Howard County Code provide for a Human Rights Commission in Howard County; and
