1           **WHEREAS**, the Department of Business and Economic Development of the State of  
2 Maryland (the “Department”) has been asked to assist in the financing of a project in Howard  
3 County through the Department’s Maryland Economic Development Assistance Authority and  
4 Fund (“MEDAAF”), as set forth in Sections 5-301 through 5-349 of the Economic Development  
5 Article of the Annotated Code of Maryland (the “State Law”); and

7           **WHEREAS**, the completion of the project described in this Resolution has strong  
8 potential for expanding or retaining employment opportunities within the County; and  
9

10          **WHEREAS**, the County Executive and County Council have determined that it is in the  
11 best interests of the citizens of the County that the Department provide the MEDAAF financial  
12 assistance described in this Resolution; and  
13

14          **WHEREAS**, the Howard County Economic Development Authority is the “designated  
15 agency” for purposes of the State Law to administer the project described in this Resolution; and  
16

17          **WHEREAS**, in accordance with the provisions of Section 5-319 of the State Law, the  
18 Department requires that the County approve a resolution endorsing the financial assistance  
19 being given by the Department for the project described in this Resolution.

21          **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,  
22 Maryland, this \_\_\_\_ day of \_\_\_\_\_, 2009, that Howard County hereby endorses the  
23 Department providing the MEDAAF financial assistance described below for the following  
24 project:

25           A conditional grant in the amount of \$250,000 to establish the Howard County Catalyst  
26 Loan Program to provide direct, low-interest loans to emerging local companies with  
27 matching funds in the amount of at least \$250,000 being provided by the Howard County  
28 Economic Development Authority.

30          **AND BE IT FURTHER RESOLVED** by the County Council of Howard County,

1 Maryland, that it hereby certifies that the project is consistent with the County's plan for  
2 economic development.

4 **AND BE IT FURTHER RESOLVED** by the County Council of Howard County,  
5 Maryland, that the Howard County Economic Development Authority is hereby designated by  
6 the County as the designated agency to act in accordance with the State Law and to administer  
7 the project described in this Resolution.
