2	would not benefit the environment, the Chesapeake Bay, nor the public welfare; and

4	Whereas, The Department of Planning and Zoning and the Planning Board have been notified of
5	this Act and have been asked to make recommendations.

9	Section 1. Be It Enacted by the County Council of Howard County, Maryland that PlanHoward
10	2030 is amended to change the Planned Service Area boundary for water and sewer service to
11	remove approximately 91.25 acres identified as Parcel 113, on Grid 2 of Tax Map 46.
12	
13	Section 2. And Be It Further Enacted by the County Council of Howard County, Maryland,
14	that, in Chapter 6 of PlanHoward 2030, under the subheading "Expansion of the Planned
15	Service Area", the first sentence of the third paragraph shall be amended to read:
16	"PlanHoward 2030 proposes two minor expansions of the Planned Service Area
17	(adjoining Ellicott City and Clarksville)."

19	Section 3. And Be It Further Enacted by the County Council of Howard County, Maryland, that
20	the parcel identified in Section 1 of this Act shall be designated as Growth Tier III.
21	
22	Section 4. And Be It Further Enacted by the County Council of Howard County, Maryland, that
23	this amendment be attached to PlanHoward 2030 and that the following be adjusted
24	correspondingly:
25	Map 6-2 Designated Place Types; and
26	Map 6-3, which shows the Growth Tiers for Howard County

28	Section 5. And Be It Further Enacted by the County Council of Howard County, Maryland, that
29	this Act shall become effective 61 days after its enactment.
