

1	WHEREAS, the County Executive and County Council of Howard County recognize
2	that there is a significant need for reinvestment and revitalization of certain communities in
3	Howard County; and
4	
5	WHEREAS, by approval of Council Resolution No. 112-2012, Howard County
6	designated an area of Ellicott City as a Sustainable Community and the designation was
7	approved by the State of Maryland; and
8	
9	WHEREAS, subsequent to the passage of CR 112-2012, it was discovered that two
10	properties located within the historic district and at the edge of the Sustainable Community were
11	inadvertently excluded from the Sustainable Community boundary; and
12	
13	WHEREAS, the properties are located at 3832 Old Columbia Pike and 3850 Old
14	Columbia Pike; and
15	
16	WHEREAS, recognizing that the two properties had been inadvertently excluded, the
17	State chose to treat the two properties as being within the designated Sustainable Community and
18	the current Sustainable Community Area is as shown on the attached exhibit (the "Area"); and
19	
20	WHEREAS, Howard County proposes to develop a Community Legacy Project (the
21	"Project") in the Area, as further described in the Community Legacy Application, the purpose
22	of which will be to contribute to the reinvestment and revitalization in the Area; and
23	
24	WHEREAS, the Maryland Department of Housing and Community Development (the
25	"Department"), either through the Community Legacy Program or through other programs of the
26	Department, or in cooperation with other state departments or agencies, may provide some or all
27	of the financing for the Project (the "Project Financing") in order to assist in making the Project
28	financially feasible; and

1	WHEREAS, the Area is located within a priority funding area under Section 5-7B-02 of
2	the Smart Growth Act, set forth in the State Finance and Procurement Article, and the Project
3	will conform to the Howard County Zoning Regulations; and
4	
5	WHEREAS, for the Project, the County seeks funding to further the Ellicott City Façade
6	Improvement Program; and
7	
8	WHEREAS, to date, the County has received and completed a \$50,000 Façade
9	Improvement Program grant and is currently working on implementing a \$100,000 Ellicott City
10	Streetscape Program grant; and
11	
12	WHEREAS, the additional funding sought in this Resolution for the Ellicott City Façade
13	Improvement Program will expand the program to include all historic façades within the Area,
14	not just façades along Main Street; and
15	
16	WHEREAS, the applicable law, regulations and Departmental requirements necessitate
17	approval of the Project and the Project Financing by the County Executive and the County
18	Council.

20	NOW THEREFORE, BE IT RESOLVED by the County Council of Howard County,
21	Maryland, this day of, 2015 that it hereby affirms the State's inclusion of
22	properties into the Area and affirms the Area, as shown in the attached exhibit, as the designated
23	Ellicott City Sustainable Community;
24	
25	AND BE IT FURTHER RESOLVED by the County Council of Howard County,
26	Maryland, that it endorses the Project, in the form of the Ellicott City Façade Improvement
27	Program, in the Area and approves the application for Project Financing in the form of a grant,
28	up to the amount of \$50,000;
29	
30	AND BE IT FURTHER RESOLVED, that the County Executive is hereby requested to
31	endorse this Resolution, thereby expressing his approval thereof;

AND BE IT FURTHER RESOLVED, that the County Executive, Director of the
 Department of Planning and Zoning, or the Deputy Director of the Department of Planning and
 Zoning are hereby authorized to execute documents and take any action necessary to carry out
 the intent of this Resolution;
 AND BE IT FURTHER RESOLVED, that a copy of this Resolution shall be sent to the

9 for consideration by the Community Legacy Board.
