I am writing to express my opposition to legislation that gives special legal protections to transgender individuals.

First, let me say that as individuals they are entitled to the same protections as the rest of us. However I fear that legislation giving them a special status can cause grave harm to them and to non-transgender individuals. In short:

- 1. Women will no longer be able to expect privacy when using public restrooms, dressing rooms, locker and the like because men will be allowed entrance to these areas, putting women and young children at risk for photographing, videotaping, unwanted contact, etc. Cross-dressing does not make a male a female. Allowing males in a female area poses serious risks.
- 2. Organizations such as the Boy Scouts may be forced to allow cross-dressing people into positions of leadership, even though the organization may fear that it can bring harm to young people.

My name is Shane Walker, a student at the University of Maryland in College Park, MD. Being at the University, I rarely get much information on local politics, but recently my father sent me a copy of the Montgomery County news report and I read that a law is being considered concerning the legalization of transgendered peoples.

I would ask you to please turn down this law.

I have arguments, many of which you have probably heard by angry, ignorant people who feel wronged by this bill. I will spare you the obvious concerns and present to you some concerns you may not have been exposed to yet:

First, there is a very clear reason why people are upset over this bill. It is the same reason that the homosexual agenda still causes arguments. We created government in order to sustain the laws and structure of our society. As you begin redefining (or undefining as we seem to be doing nowadays) values such as *family*, *gender*, and *citizenship*, the structure begins to deteriorate. Mat Staver of <u>Liberty Counsel</u> tells OneNewsNow the male customer -- who was wearing make-up and girl's clothing -- angrily responded that he was a "female."

"Then [he] contacted the management and said that this was an LGBT-friendly store," the attorney explains. "And to Natalie Johnson's surprise, management took the customer's position and affirmed that it is an LGBT-friendly store and said that according to their policy, 'transgendered' people can change in any dressing room they want."

Johnson pointed out to management the consequences of the policy and the potential danger to women and offensiveness of the policy, as well as that it violated her religious beliefs. She was fired.

"Natalie's situation represents what we're going to see around the country if we have this LBGT agenda continue to advance. It literally has become the theatre of the absurd," Staver offers.

"This policy at Macy's is fraught with problems -- it will alienate and offend the majority of their customers, particularly women," he continues. "They obviously do not, nor should they have to put up with, men using the women's fitting rooms."

Staver is hopeful customers of Macy's nationwide will contact the firm and ask officials to redraft the policy to a commonsense one -- that being that women's fitting rooms are for women and men's rooms for men.



I am Jennifer Lewis. I live in Howard County. I am testifying in support of CB54-2011. Thank you for hearing our story.

I have direct experience with individuals who vary in gender expression.

In April my own child came out to me in a letter stating she had gender dysphoria and felt like a boy trapped in a girls body. While reeling from this unexpected blow, snapshots of her life came to me: conversations as a toddler about when she'll get her penis, shopping in the boys section for clothing, years of being called "he" by every stranger we met, being confronted in the gym locker room (even while wearing a female swim suit)- by strangers saying my son is too old to be in a female's locker room, which incensed me but never bothered her. The list went on. How did I miss it? The letter went on saying how she prayed to be a boy and eventually resorted to asking Santa each year- to make her one. And from here on, I will refer to him as my son.

He asked to be called Riley and for us to use male pronouns. Having named him after my late sister, it was like she died all over again. Like I lost a sister and a daughter. A day or so later Riley asked me to help find a home for a young cat that showed up in our neighborhood. It ended up biting me and running off. A couple days later, I was in the hospital being treated for sepsis and vaccinated for rabies. I had three days in the hospital to remember what was important. My child's health and happiness. As he was already a wonderful person and going through a very difficult time. It reminded me that this is not about me. It is about empowering my child to be authentic.

The thing which worries me the most now is my son's safety. Of all the roadblocks in his future, of all the prejudice and judgement that will stand in his way – knowing there are no laws protecting him from discrimination. He can get fired from a job, kicked out of programs, kicked out university housing, and banned from participating in the sports he loves so well-- simply for being authentic. What does that say about our community when we aren't supporting our citizens?

The person you are supporting by passing this amendment is my son-- a model citizen. In the ninth grade, he is in all gifted and honors classes. He's so far ahead in math that by the 11th grade he'll have to go off campus for class. He wants to be an endocrinologist and help treat others with medical conditions like his. He has steady babysitting jobs; performs with the high school marching band and choir; he has many friends who know and support him; and continues to want to find homes for every stray we find.

His birthday is in six days- he'll be fifteen and deserves the same rights afforded to every other human in Howard County. Thank you.

Wesley Garson, Acting Director of The Transgender Civil Rights Project in Favor of Howard County Bill No. 54-2011 November 18, 2011

My name is Wesley Garson and I am Acting Director of the Transgender Civil Rights Project at the National Gay and Lesbian Task Force in Washington, DC. On behalf of the Task Force, I am pleased to provide this statement of strong support for Howard County Bill 54.

Over the past 11 years, The Transgender Civil Rights Project has been a leading force in ensuring that transgender and gender nonconforming people are protected under the law. Our staff has closely followed developments around the country, and, working closely with partners in each jurisdiction where we have advocated for change, drafted local, state and federal legislation to prohibit discrimination based on gender identity and expression. As one facet of this work, The Transgender Civil Rights Project has assisted many localities with passing legislation similar to the bill before us today. The results of this advocacy work have been extremely favorable.

Today, the federal government has a policy in place prohibiting discrimination against civil federal employees who are transgender people. Currently, over 100 local jurisdictions have enacted nondiscrimination ordinances protecting people on the basis of gender identity; the first passed in Minneapolis in 1975. Laws to protect transgender people from discrimination have been enacted in jurisdictions across the county, including in places that some might consider unlikely, such as counties in Kentucky and 12 local jurisdictions in Utah.

Additionally, 16 states have statewide prohibitions on gender identity discrimination, including Massachusetts, where the legislature passed its law last week and the governor signed it last Wednesday. Minnesota was the first state to enact these provisions in 1993. Colorado, Iowa and Vermont enacted their laws in 2007. Additional states include California, Connecticut, Hawaii, Illinois, Maine, New Jersey, New Mexico, Nevada, Oregon, Rhode Island, and Washington. Along with these 16 state laws, Collectively, if you add up all the people that live in these jurisdictions, approximately 40% of the U.S. population is covered by one of these laws.

Bill 54 would add Howard County to this growing list by adding "gender identity or expression" as a protected characteristic to provisions in local laws including provisions prohibiting discrimination in employment, housing, public accommodations and more. It would add this category to the existing local human rights code, and be enforced by the same body that enforces

local laws prohibiting discrimination on other bases. Thus, the protection mechanisms are already in place, and can work well.

Further, we know from other jurisdictions that anti-discrimination laws have been successfully implemented. Over the 36 years since the first local law like Bill 54 was enacted, government agencies charged with enforcement, such as human relations commissions, have been able to handle the small number of formal complaints brought to them. Notably, just a few lawsuits have been filed under these laws anywhere they have been adopted. Importantly these laws work as intended, to give transgender and gender nonconforming people tools to address bias or discrimination where it affects them, and to convey to businesses and employers that discrimination on the basis of gender identity is wrong and will not be tolerated.

We know from speaking with attorneys and enforcement agencies around the country, most instances of potential or pending discrimination are resolved informally when businesses and institutions are made aware of the law. This has had the positive effect of preventing discrimination before it happens. More rarely, discrimination claims are investigated and processed by the local agency charged with enforcement, here that would be the Howard County Office of Human Rights. In Maryland, there are two local jurisdictions with similar laws, and both are working well. Baltimore City and Montgomery County have had law to prohibit discrimination in place for 9 and 4 years, respectively. Thought opponents of this measure may argue that this law will cause a number of problems, the experiences of Baltimore City and Montgomery county clearly demonstrate otherwise. Neither jurisdiction has had any problem enforcing the law, and no unintended consequences have materialized.

Laws like this help address and counter a problem that we have been aware of anecdotally for several years, but which we now have empirical data to show more clearly. In March of this year, the National Center for Transgender Equality and my organization, the National Gay and Lesbian Task Force, released a groundbreaking report, Injustice at Every Turn: A Report of the National Transgender Discrimination Survey. This study was the first national study of its kind and included over 6,400 people in the nationwide. Especially relevant to the ordinance under consideration today, one hundred and thirty-two (132) respondents to the survey were from Maryland. The study found that Maryland transgender and gender non-conforming people were being fired, harassed, passed over for promotion, and not hired simply for being who they were. This is not a small problem: 71% experienced harassment or mistreatment on the job and 18% had lost their job just because of who they are. Likely due to this discrimination, Maryland's transgender residents experienced poverty (making under \$10,000 per year) nearly 3 times the national average. Likely also due to troubles with employment discrimination as well as housing discrimination, 12% of transgender Marylanders had experienced homelessness. Seventeen percent (17%) were denied a home or apartment because they were transgender. Twenty-two percent (22%) had to find temporary spaces to stay in an attempt to avoid homelessness.

This county ordinance is vitally important; it can save jobs, homes, families and literally save lives. Income from employment is critical to paying for shelter, food, health care --- things that all people need to live. We all know that this is a difficult economic environment for many in which to find work, pay the rent, and keep a family fed and clothed, and that can be hard even without discrimination standing between a person and all of these basic life necessities. All

Howard County residents should have the right to seek and keep employment, housing and appear in public without being turned away or treated badly due to bias. The laws of Howard County should provide these basic tenets of equal opportunity to transgender individuals, in the same way as it already does so based on gender, race, disability, religion, and other protected characteristics.

For all of the aforementioned reasons, I urge you to pass Howard County Bill 54. By doing so, you will be adding this county to the list of jurisdictions around the country where the law conveys that transgender people are to be treated fairly and without bias based on gender identity or expression. But most importantly you will be helping transgender and gender nonconforming people to help themselves, by providing them with a vital tool to use if they find themselves facing discrimination in a wide variety of contexts. Ideally, people would not be treated unjustly based on who they are, but when that fails the next most important thing is being able to do something about it. With your help, in Howard County, the law would provide that.



Dear Honorable Councilmembers,

My name is Sharon Brackett and I am pleased to speak in support of CB54-2011. I will do so in two capacities. I am presently the Board Chair of Gender Rights Maryland (GRMD), a statewide transgender rights organization. But I am also resident of Howard County and have been so since 2004.

On April 18th, 2011 Chrissy Polis was savagely and brutally attacked in a Rosedale, Maryland McDonalds. Her offense at the time was being transgender and using the facilities in the restaurant. The attack was a wakeup call to the general public that remained largely unaware that transpeople regularly bear the brunt of discrimination and violence in Maryland and around the nation. It was a vivid demonstration that this discrimination is real, and can happen in any public space, in any city, suburb, or neighborhood, even yours. One merely need watch a few moments of the horrific video captured during this event to understand. The sad reality is this kind of thing happens often; it is just that this one time we were "lucky" that it was captured for all to see and subsequently went viral on the Internet. And in this case the victim survived to tell the tale.

Unfortunately, most discrimination against transpeople is unseen, undocumented, tolerated by others and most often unprosecuted. Too often we find ourselves at a candlelight vigil in response to a violent episode. And that ignores those instances where the job lost, or housing or appropriate medical treatment denied.

A recent study of transpeople by the National Center for Transgender Equality (NCTE) and the National Gay and Lesbian Task Force (NGLTF) reported that 90% of those surveyed reported harassment, mistreatment or discrimination at work. 47% indicated they had been fired, not hired or denied a promotion as a result of being transgender or gender non-conforming. 53% reported being verbally harassed or disrespected in a place of public accommodation, including hotels, restaurants, buses, airports and government agencies. And when added to existing structural racism, the numbers are even more alarming for people of color. Clearly this cannot stand in Maryland and in my home of Howard County.

What is needed is the education of individuals, business owners, and our elected officials. The notion that a person who is merely "different" does not represent a threat to you must become a cultural norm. We must teach that if a person makes you uncomfortable, for any reason, the issue most assuredly is yours, not theirs. We must teach that harassment and violence against transpeople is not acceptable under any circumstance.

In our nation where equality is revered, it must be visibly and regularly practiced by all, including those who represent them in elected and appointed office.

You will hear some this evening who will use the language of fear to describe transpeople. I urge you to substitute Black, or Hispanic; Jew or Muslim; Gay or Lesbian; where they will reference transpeople in their words. You will be astounded by the similarity of language from days long gone. Their message, "Different than me is bad, and a threat". It is the language of fear and hate, and we are better than that.

In May of this year Governor O'Malley, in response to the prosecution of Polis hate crime, stated that "Even with Maryland's 'hate crimes' law, it is clear that more must be done to protect the rights and dignity of transgender people." He further committed to passing expanded protections for transgender people. This call to action is the first time we have seen such a clear recognition of these issues. We applaud the Governor for this stance, as we do for our councilmember sponsors in this present effort.

It is unfortunate that new law alone will not remedy this situation. This is demonstrated by the recent rash of violent attacks in the District of Columbia, with the most progressive laws protecting transpeople in the nation, as well as in Baltimore City, made a protected space for transpeople by then-Mayor O'Malley in 2002. Changes in the law, while not the whole answer are a critical and fundamental starting point. Absent that starting point it is hard to make progress with the public unless our leaders set an example. This has been the case with nearly every civil rights movement in our history. We implore you — Let's make it no longer "OK" to discriminate against transpeople in our county and demonstrate to the rest our state, and nation what courage and change really look like.

On a more personal front:

I transitioned in Howard County in 2010. I was blessed by the tolerance, understanding and acceptance of the good people of Howard County. That is not to say that my journey has not been without sacrifice. Three years ago I was married, a homeowner, a business owner and employer in Howard County, and I was employed as the President of my company, a position I had enjoyed with success for over a decade. Today I have none of those things, and much of what I have built over the past 25 years has been lost

to me. Despite my success in leading my company in being to the Inc. 5000 list of fastest growing companies for four consecutive years (2007-2010), and being selected a Washington Smart 100 CEO in 2010, and again in 2011 after transition, I no longer serve with the company I helped found. I am the same person, with the same drive and intelligence. Today I find that I am essentially starting over, now at 50 years in age. And in all of that the only thing that has substantially changed for me is the public perception of my gender, and my election to receive treatment for a medical condition.

Prior to transition, as I explored my options in that treatment, naysayers appeared to tell me how much I was going to damage my teenage sons by doing so. Making dire predictions, and decisions made in fear. I was lucky, my children saw past that. They have been my greatest supporters. That big fellow over there with the shock of red hair is my 17 year old son who today lives with me, a Senior at Atholton High school, where I serve as the lead adult mentor for his Robotics Team.

Because of the collapse of my marriage I found myself renting a home for the first time in nearly 20 years. I hid the facts of my transition from my landlord for fear that he could have me tossed from the home should he desire. I lived in fear of this daily for a year and only revealed my transition when he had decided not to renew my lease. And all of this angst because there is no protection in this state and county for those who are transgender.

Has the discrimination I have experienced been blatant? No, fortunately I have not been assaulted, verbally abused or otherwise physically harmed. The discrimination is much more insipid. It's the Howard County police officer that started the conversation with "Good evening Ma'am may I see your license", and ended it with a terse "Here is your license, Sir" done loudly to embarrass me in front of my passengers. The County Judge, who even though I never once presented as male in the court, and had evidenced change of name and gender, and other documents, regularly referred to me as "him" or "his". The voracity of a divorce proceeding where I was portrayed as a freak, or deviant, mentally ill and a risk to my children. And the decisions of others to my being "suitable" to represent them in other matters.

I urge you to pass this bill so that we can see transgender persons, like me, take their rightful place without prejudice as productive members of our community. We have much to offer and I would hope we all get the chance to participate fully, and on a level playing field. We do not want to be special, we want to be just like everybody else.

C. CHRISTOPHER BROWN GENERAL COUNSEL The ACLU of Maryland strongly supports Bill No. 54-2011 as providing vital protection to Howard County's transgender residents. It should receive a favorable vote from the County Council.

Howard County's current antidiscrimination law prohibits discrimination based upon race, creed, religion, handicap, color, sex, national origin, age, occupation, marital status, political opinion, sexual orientation, personal appearance, familial status, and source of income, but as yet provides no explicit protection for transgender individuals, leaving them vulnerable to discrimination in all areas of civic life. This bill closes that loophole.

The perverse effect of the loophole in current law is to leave some of those who most need the protection from gender-based discrimination without it. It is clear that some of those who suffer from unfair or biased treatment by others are those who appear most visibly to depart from the traditional conventions of gender. Discrimination against transgender individuals can be brutal and is pervasive. The ACLU of Maryland receives calls from victims of such discrimination regularly and from all regions of the State. It is important to understand that this discrimination occurs against self-identified transgender individuals AND against those who do not appear to be or behave masculine enough or feminine enough. The discrimination can involve loss of a job, the refusal to provide services, the infliction of humiliating treatment, and abuse. Without the protection of the law, victims of such acts have little recourse and those bad actors have no incentive to change policies, enforce existing policies, or change their behavior.

While victims of gender based discrimination could try to litigate the issue in court, this is time-consuming, expensive proposition which would have an uncertain result as Maryland law is unsettled on this issue and the federal courts have yielded widely differing results with no clear decision in our Circuit. The ACLU is familiar with just how burdensome it is to litigate such cases and the personal toll that it takes because the national ACLU litigated a case on this issue in the United States District Court for the District of Columbia – Schroer v. Billington, 577 F. Supp.2d 293 (D.D.C. 2008). The Schroer case lasted over four years, and required over 2500 attorney hours, and nearly \$100K in out-of-pocket costs and fees, for the liability phase alone. We faced three motions to dismiss and a motion for summary judgment before Ms. Schroer was ever able to get her day in court. Instead of accepting responsibility for discriminating against a well-qualified individual solely on the basis of her gender identity, over the course of discovery, the Library sought highly personal medical records and personal

correspondence from Ms. Schroer. Ultimately, Ms. Schroer won her discrimination case, and the current Administration correctly declined to appeal it. However, because the *Schroer* case would not control any Maryland court, and because there are no high court decisions from Maryland explicitly endorsing either the "sex stereotyping" theory or the other theory credited by the court in *Schroer* (comparing gender transition to religious conversion), transgender litigants in Maryland would be starting from scratch.

This further demonstrates just how important it is for the Howard County law to be crystal clear about the fact that discrimination on the basis of gender identity and expression is illegal. When employers understand that the law now makes it illegal to discriminate on the basis of gender identity and expression, most of them will do the right thing from the outset, making litigation like the kind that Ms. Schroer had to endure unnecessary. In the rare event where more is needed, the Office of Human Rights will stand ready to enforce this law, which would provide explicit protections. Sixteen states and 110 cities and counties have laws that protect transgender individuals, including California, Colorado, Hawaii, Illinois, Iowa, Maine, Minnesota, New Jersey, New Mexico, Oregon, Rhode Island, Vermont and Washington, as well as the District of Columbia. These laws cover 40% of the U.S. population. Here in Maryland, Baltimore City has prohibited discrimination based on gender identity or expression (among other bases) in public accommodations, housing, employment, and education since 2002. And Montgomery County Maryland has prohibited people from such discrimination in employment and housing since 2007.

Corporate America has also been a leader in protecting their transgender employees. 153 Fortune 500 companies include protections for transgender employees in their nondiscrimination policies. This is more than 10 times the number that had such policies in 2001. These companies span all industries and include DuPont, Walgreens, and Coca Cola. Along with these Fortune 500 companies, 3,000 other companies, universities and labor unions prohibit this form of discrimination. Maryland companies that have a non-discrimination policy that covers gender identity include Goucher College, John Hopkins University, Sodexho Inc. and the University of Baltimore. 

My spouse of 13 years is in transition from male to female and living openly as a woman. As a Federal Government employee she is protected against discrimination and has been fully supported in the workplace and treated with respect. Ironically, I am the one who's forced into the closet. I am a State employee working full-time in a small private school in Howard County, MD. I have to hide the fact that I am now in a samesex marriage to avoid harassment on the job. I don't feel comfortable even updating my spouse's name (now legally changed) on my emergency contact form for fear of our situation becoming office-wide gossip. On the one occasion when I did confide in a coworker, I was immediately barraged with inappropriate questions and insensitive, offensive comments. The verbal abuse soon escalated into open hostility and physical intimidation. My only recourse was to "out" myself to Personnel, which I felt would only exacerbate the problem. I am the only female in my department and the climate is decidedly conservative. I am proud to acknowledge my partner and our commitment to each other in all other aspects of my life, but if my status were known at work I would be subject to humiliation and ridicule. Given the current budget crisis, it's possible I could also lose my position. Positive change happens one person at a time. *I urge you* to pass the gender identity bill at this evening's council session. It's the right thing to do, as this bill not only protects the rights of the transgender community, but the rights of couples, friends and families of transgender people. Howard weighs gender identity bill after statewide law fails

Transgender advocates turn to county to ensure anti-discrimination protection

After suffering a defeat in the state legislature, advocates pushing to bar discrimination against transgender people are looking to build protection into local laws — spurred on by a high-profile attack on a woman at a Baltimore County McDonald's last spring.

On Monday, Howard County will become the latest local government to take up a bill that would add gender identity and expression to the county's anti-discrimination laws. The measure, which has the support of a majority of the County Council, would make Howard the third local government in Maryland to adopt such a measure.

"The state hasn't done the job," said Sharon Brackett, board chair of Gender Rights Maryland, which helped an


organization in Howard craft local legislation. If there was a statewide law there wouldn't be a need in Howard, she said.

Montgomery County and Baltimore had such protections in place before the April attack on Chrissy Lee Polis, a transgender woman who had attempted to use the women's restroom at a Rosedale McDonald's. Howard is the first area locality to consider action since that attack, which was filmed and posted on YouTube, drawing millions of views worldwide.

Baltimore County and some other local governments say they are waiting for the General Assembly to take action. Advocates say they are working to gather support for a statewide bill, but are also looking to put local measures in place where they can.

"It's important that everyone is able to live in a safe environment without fear of discrimination," said Howard County Council Chairman Calvin Ball, an East Columbia Democrat. Four of the five council members are cosponsors of the measure, which would bar discrimination in housing, employment, law enforcement practices and public accommodations in the county.

Councilman Greg Fox, the lone Republican on the panel, said he is reserving judgment on the proposal. There is a public hearing scheduled for Monday.

"I have concerns about it," he said, but added, "I will listen to the testimony."

Members of the Columbia-based group, Parents, Families and Friends of Lesbians and Gays — also known as PFLAG — approached members of the council in July to get the legislation on the council agenda.

"We were very disappointed when the legislation didn't pass on the state level last year," said Catherine Hyde, transgender network coordinator for PFLAG. Hyde has a transgender daughter who was born a male.

While Howard officials look to adopt local legislation to protect gender identity, other counties continue to wait for the state to broach the issue.

Dave Abrams, a spokesman for Anne Arundel County Executive John R. Leopold, a Republican, said the administration has no plans to address the issue through local legislation.

"I believe that the county's rules match the state law," said Abrams. "If the state law changes, we will follow the state law."

In Baltimore County, the Human Relations Commission, which enforces the county's anti-discrimination law, has not explored the issue, said county spokeswoman Ellen Kobler. "It just hasn't come up on their agenda," she said.

Fifteen states, the District of Columbia, and more than 140 municipalities have gender identity protection laws, Brackett said. Such measures have been controversial when they've come before other governments, as well as in Annapolis.

Although the bill in Montgomery County was passed unanimously, a group of petitioners attempted to put the measure before voter referendum. The law protects transgender people from discrimination in housing, employment, public accommodations, and taxi and cable service.

Opponents gathered 32,000 signatures to put the measure to voter referendum, but Maryland's highest court removed the measure from the ballot, ruling that opponents had not collected enough signatures. The Montgomery County bill took effect in 2008; Baltimore's measure has been in place since 2002.

Opponents to the Montgomery County law had raised concerns over public restrooms, which would also be affected under the measure being proposed in Howard.

Greg Quinlan, the Executive Director of Equality and Justice for All, called Howard's proposal "bad public policy."

He said his group, which is based in Arlington, Va. and fights such laws across the country, plans to send representatives to the public hearing Monday.

He argued that the legislation would violate the civil rights of others by allowing transgender individuals to use the restroom of people of the opposite sex.

"It's giving them a special rights. It's not a civil right," he said.

For Laurel residents Brian and Maria Singer, who plan to testify at the hearing, the bill means basic rights for their 6-year-old daughter, Jackie.

Jackie Singer was born a boy and named Jack, but the elementary school student wears dresses, loves Barbie dolls, and thinks of herself as a girl. Her doctor has identified her has having a gender identity disorder.

"Right now, it doesn't affect us too much," said Brian Singer. "It's easy to protect Jackie because she is only six." Still, he said, she has already faced bullies who don't understand why a boy would want to dress as a girl — and she sometimes wonders why she is not accepted in the girls lavatory at school.

He says the legislation in Howard will become increasingly important as Jackie grows up.

Referring to the attack on Polis, he said, "I don't want that to happen to my daughter."

The incident at the Rosedale McDonald's, captured on a restaurant employee's cellphone, pushed discrimination of transgender people into the forefront of public debate. One of the teens involved in the altercation has since pleaded guilty in Baltimore County Circuit Court to one count of first-degree assault and one hate crime count.

The beating came shortly after the failure of a state law that would have provided some protections for transgender individuals in Maryland. The final version of the bill didn't include public accommodation protections that could protect transgender people from being discriminated against in restaurants and public places; Howard's bill contains those provisions.

The statewide bill had made it further than in past years, passing the House of Delegates. But it failed to earn enough support on the Senate floor.

Under the bill in Howard, transgender individuals would receive the same protections that aim to prevent discrimination based on race, religion or political beliefs.

"It's about basic human rights, being treated fairly in public places," said Heath Goisovich, a PFLAG cochair of the advocacy committee.

Brackett said there are a number of transgender individuals in every community. Proponents on Monday will wear purple in a show of support.

"You probably know a transgender person but you don't even know it," she said.

Good morning. My name is Cathy Brennan, and I am a lawyer and longtime lesbian activist writing regarding CB54-2011, which would amend the Howard County Code to add "gender identity" as a protected classification under the County's nondiscrimination statutes.

As written, the definition of gender identity appears over broad and would codify stereotypes about males and females into law. This is a <u>bad result for females</u>, who have struggled AGAINST such stereotyping for centuries. I have attached a paper another lawyer and I submitted to the United Nations Commission on the Status of Women in August that discusses the various definitions of "gender identity" used in other states, along with proposed language that is narrowly tailored to protect actual transgender people without running roughshod over female interests.

I also note that you attempt to avoid the issue of single-sex public accommodations by stating that "PUBLIC ACCOMMODATIONS DOES NOT INCLUDE ACCOMMODATIONS THAT ARE DISTINCTLY PRIVATE OR PERSONAL." Without a more robust definition of what is meant by private or personal, I would suggest you are inviting litigation risk - risk that, in these times of economic uncertainty, I would suggest that the County would do well to avoid. If you don't

want gender identity protections to override protections based on biological sex (as I hope is the case), you should state this explicitly.

Howard County, Maryland -- Equality and Justice For All, a newly formed grassroots organization promoting fair and equitable laws for formerly gender confused individuals (ex-transgenders), exgays, and the heterosexual population, today urged the Howard County Council to reject legislation imposing gender confusion on Marylanders in Howard County.

"Transgender laws discriminate against women by forcing us to recognize men as females," said Harley. "The government forces the people to deny reality under the penalty of law."

Similarly, a transgender rights bill passed in Montgomery County, Maryland against the wishes of the residents resulted in the bill's sponsor, former Councilmember Duchy Trachtenberg, as the only councilmember defeated in re-election. The unpopular gender identity law was set for referendum until gay activists sued to stop the vote of the people.

A local citizens group filed an <u>ethics complaint</u> against Trachtenberg' assistant, Dana Beyer, for harassing residents who were trying to obtain signatures to place the law on referendum. Beyer responded by suing the County for \$5 million, citing emotional distress and using the new gender identity discrimination law to bring the lawsuit. Subsequently, Montgomery County refused to consider testimony of witnesses who were victims of the harassment because they did not use the correct pronouns when referring to transgenders.

In other jurisdictions, governments are being forced to pay thousands of dollars for sex change operations.

The Howard County Council has scheduled a hearing on the transgender bill for November 21.

Re: Hearing on Transgender Anti-Discrimination Bill

Good evening, Council Members. Thank you for allowing me to testify today. My name is Rich Espey, and I have taught middle school science for 23 years. Currently, I am teaching eighth graders at the Park School in Baltimore. I am here today on behalf of GLSEN, the Gay, Lesbian & Straight Education Network. GLSEN strives to assure that each member of every school community is valued and respected regardless of sexual orientation or gender identity or expression. I am honored to have been named GLSEN's Teacher of the Year for 2011.

I am so happy to support this bill, which would provide critical nondiscrimination protections to Howard County residents from all walks of life, including some of our most vulnerable students, on the basis of gender identity and expression in employment, housing, health, and education. As an educator, I have seen that laws that create nondiscrimination protections for students, like this ordinance, help to create a safe, respectful, and welcoming school environment for all students that is conducive to learning.



Learning in a safe school environment, one free from bullying, harassment, and discrimination, is a right entitled to all students. Such an atmosphere engenders a positive sense of self, which is the basis of educational achievement and personal growth. Unfortunately, transgender and gender nonconforming students are frequently subjected to bullying, harassment, and discrimination every day in schools across America. In fact, gender identity and gender expression are among the top three reasons students are bullied and harassed at school. GLSEN's research has shown that more than 6 in 10 students report hearing biased remarks about students' gender expression often or frequently in school. More than 1 in 4 LGBT students reported being physically harassed at school because of how they expressed their gender. Yet over 60% of students who experienced harassment or assault in the past year did not report these experiences to school personnel. When asked why they chose not to tell school personnel about their experiences with harassment or assault, many said that they believed nothing would be done to address the situation. Others said that reporting would not be worth it because reporting had not been effective in the past.

Additionally, some students aren't aware that their school district has a policy that explicitly prohibits bullying, harassment, and discrimination based on gender identity and/or gender expression The adoption of a county ordinance that explicitly prohibits discrimination based on gender identity and gender expression is essential to



ensuring the well being of students because it would convey to both students and educators that bullying, harassment, and discrimination on these bases is unacceptable.

Transgender and gender nonconforming students are particularly vulnerable in schools. GLSEN's research shows that a staggering 82% of transgender students across the country feel unsafe at school. Nearly half of transgender students missed at least one day of school in the past month because of safety concerns. Unfortunately, it is not surprising that these students feel unsafe. 41% of transgender students said they had been physically harassed sometimes, often, or frequently in the past school year. This is unacceptable.

It is our understanding that the school district has already approached the Howard County Human Rights Commission about developing guidelines to protect transgender and gender nonconforming students. We applaud Howard schools for this proactive step. GLSEN encourages districts to adopt policies that address areas such as use of appropriate names and pronouns, gender segregated activities, and privacy and confidentiality in gender identity transition.

Research has shown that laws and policies that prohibit discrimination based on characteristics that are frequently the target of bullying, harassment, and discrimination, including gender identity and expression, help create safer schools for all students. Currently, many jurisdictions across the United States, including 13 states and



the District of Columbia as well as a number of counties, protect students from discrimination based on gender identity and gender expression. On behalf of GLSEN, and as an educator myself, I urge you to join them and take the important first step of passing this bill.

Dear Members of Howard County Council:

Parents and Friends of Ex-Gays and Gays object to Howard County's Bill 54-2011, which will add "gender identity or expression" to the classification list of individuals who are protected against discriminatory practices.

The proposed, flawed law insufficiently and incorrectly defines "gender identity or expression" as follows:

Gender Identity or Expression means a Gender-Related Identity or Appearance of an Individual regardless of the individual's assigned sex at birth.

Laws need to be clear and non-ambiguous to be constitutionally acceptable. <u>Using the words "gender-related identity" to explain what "gender identity" means and "expression" to explain "appearance" is circular and fails to explain or define anything.</u>

For the average person, the "gender identity" of a stranger is based on the actual visual presentation of that stranger and is perceived to be either male or female. The average person cannot know what the stranger's possible mental disordered thinking is or what, if any, deception or irregularity exists in the stranger's possibly contrived appearance.

The American Psychological Association's Committee on LGBT Affairs fact sheet notes a vast number of variations in gender identity that deviate from binary male/female identity and appearance. ^[1] These "variations" are generally defined as "mental disorders by the American Psychiatric Handbook of Mental Disorders." Such variations include, cross dressers, transsexuals, multigendered, and even voyeurs attempting to mask their deviant desires. Exact definitions of these terms vary from person to person and may change over time, but often include a sense of blending or alternating genders.

Remember an individual who is a biological male but identifies as a female still retains a sexual preference for a female.

The proposed "definition" of "gender identity or expression" does nothing to advise the average person what scrutiny, perception or comprehension is required by that person to avoid prosecution. The proposed law is unconstitutionally vague and does not enhance the present code of Howard County. It only adds gender confusion.
