1           **WHEREAS**, Section 11.201 of the Howard County Code provides that the County  
2 Council shall set the fee for issuance of a lien certificate; and

4           **WHEREAS**, Section 21.206 and Section 21.236 of the Howard County Code authorize  
5 the Department of Public Works to establish parking meter zones and prohibit a person from  
6 parking in a parking meter zone unless the appropriate fee is paid; and

8           **WHEREAS**, Section 14-813 of the Tax-Property Article of the Annotated Code of  
9 Maryland allows certain expenses of a tax sale to be charged including, without limitation,  
10 advertising notices, paying for the auctioneer, obtaining the advice of the County Solicitor and  
11 sending certified letters to property owners after tax sale.

13           **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,  
14 Maryland this 20<sup>th</sup> day of May, 2009, that it adopts the attached schedules of fees;

17           **BE IT FURTHER RESOLVED** that these fee schedules shall be effective July 1, 2009  
18 and shall continue in effect until changed or repealed by subsequent resolution of the County  
19 Council.

## PARKING METER RATES

*These rates are adopted pursuant to Sections 21.206 and 21.236 of the Howard County Code, which authorize the Department of Public Works to establish parking meter zones, and which prohibit a person from parking a vehicle in a parking meter zone unless the applicable rates have been paid.*

Ellicott City Post Office Lot	\$.25 per hour per space
Patapsco River Lot in Ellicott City	\$.50 per hour per space
Maryland Ave. Lot in Ellicott City	\$.50 per hour per space
Talbot Lot in Ellicott City	\$.25 per hour per space
