1 **WHEREAS**, a seven member Compensation Review Commission is established and is
2 empowered to set compensation and allowances to be paid the members of the County
3 Council pursuant to the authority of Article 25A, Section 5(AA) of the Annotated Code of
4 Maryland and Section 202(d) of the Howard County Charter and Subtitle 1. Compensation
5 Review Commission of Title 5 County Council of the Howard County Code; and

7 **WHEREAS**, pursuant to Section 302(e) of the Howard County Charter, the Compensation
8 Review Commission shall review the County Executive's compensation and allowances
9 and make recommendations to the County Council regarding same.

11 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,

6 The Commission shall elect from its members a chairperson, a vice chairperson and such
7 other officers as it shall deem appropriate.
8

9 **AND BE IT FURTHER RESOLVED** that the Commission shall by resolution submit its
10 recommendations to the County Council not later than December 15, 2009 relative to the
11 compensation and allowances of the County Executive and County Council to be elected in
12 November 2010. The Commission may recommend an increase or decrease in the
13 compensation and allowances paid to the County Executive and members of the County
14 Council but in no event may compensation be less than provided in the Howard County
15 Charter.

17 **AND BE IT FURTHER RESOLVED** that the Commission shall also submit its
18 recommendation to the County Council concerning compensation and allowances of the
19 County Executive to be elected in November 2010.

21 **AND BE IT FURTHER RESOLVED** that the commission shall hold public hearings
22 which shall be advertised at least two weeks in advance in at least one newspaper of
23 general circulation in Howard County. Notice of all meetings, public hearings and work
24 sessions of the Commission shall also be posted on the County Council bulletin board at
25 least two weeks in advance of such sessions.

27 **AND BE IT FURTHER RESOLVED** that the Commission shall terminate and cease to
28 function on April 30, 2010.
