1 **WHEREAS**, Section 404 of the Howard County Charter and Section 6.300 of the
2 Howard County Code provide for the County Executive to appoint and for the County Council to
3 confirm nominees to Howard County Boards and Commissions created by law; and

4 **WHEREAS**, Sections 3-102 through 3-107 of the Tax-Property Article of the Annotated
5 Code of Maryland provide for a Property Tax Assessment Appeal Board in Howard County; and
6 also provide that the County must submit three names to the Governor for each vacancy on the
7 Board; and

8 **WHEREAS**, the County Executive has proposed the that the names of George A. Ford,
9 Jr., Michelle Baker and Sara Hammer be submitted to the Governor for appointment as a
10 member of the Property Tax Assessment Appeal Board; and

11 **WHEREAS**, the County Council ratifies the County Executive's special trust and
12 confidence in the abilities of the nominees.

13 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
14 Maryland this 1st day of September, 2009 that the following names are approved for
15 submission to the Governor for approval as an alternate member to the Property Tax Assessment
16 Appeal Board to serve from the passage of this Resolution to June 1, 2013 or until a successor is
17 appointed and confirmed:
