1	WHEREAS, Section 3.1007 of the Howard County Code authorizes the Director of the		
2	Department of Inspections, Licenses and Permits to grant a waiver of the requirements of		
3	Howard County's Green Buildings Law where, by reason of unique physical characteristics of		
4	the property including exceptional topographic conditions or the size or shape of the property,		
5	strict compliance with the requirements of the Green Buildings Law would result in an		
6	unwarranted hardship to an applicant for a building permit; and		
7			
8	WHEREAS, Section 3.1007 also provides that an unwarranted hardship does not include		
9	financial hardship; and		
10			
11	WHEREAS, Section 3.1007(c) provides that an applicant who is granted a waiver shall		
12	pay a fee-in-lieu into the Green Building Fund that is calculated on a square-foot basis at a rate		
13	established in a fee schedule adopted by Resolution of the County Council; and		
14			
15	WHEREAS, the Green Building Fund will be used to find ways to reduce energy		
16	consumption; to provide technical assistance to certain building owners seeking to achieve		
17	certification from the Green Building Council; and to provide education, training, and outreach		
18	in green building practices; and		
19			
20	WHEREAS, the County Executive, upon the recommendation of the Director of		
21	Inspections, Licenses and Permits and the Administrator of the Office of Environmental		
22	Sustainability, has proposed a fee-in-lieu for a waiver of the Howard County Green Buildings		
23	Law.

25	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County,		
26	Maryland this day of, 2009 that it adopts the following fee-in-lieu for a		
27	waiver of Howard County's Green Buildings Law:		
28	\$4 per gross square foot

30	AND BE IT FURTHER RESOLVED that this fee-in-lieu shall be effective October 15,		
31	2009 and shall continue in effect until changed or repealed by subsequent resolution of the		
32	County Council.
