## DESCRIPTION TAX MAP 37, P/O PARCEL 289 HOWARD COUNTY, MARYLAND 0.60 ACRES (26,317 SQUARE FEET), MORE OR LESS

- 7) North 45 degrees 59 minutes 24 seconds West, 73.74 feet to a point on the right-of-way line, thence along said right-of-way line;
- 8) North 32 degrees 05 minutes 37 seconds West, 249.83 feet to a point on the right-ofway line, thence along said right-of-way line returning to the point of beginning.


