**WHEREAS**, Section 610 of the Howard County Charter authorizes and empowers the Howard County Council to make supplementary appropriations from the unexpended and unencumbered funds set aside for contingencies in the County budget; and

**WHEREAS**, pursuant to the American Recovery and Reinvestment Act, the County has been awarded funds from the Maryland Department of Housing and Community Development for the Homelessness Prevention and Rapid Re-Housing Program (HPRP/RAP) Program; and

**WHEREAS**, grant funding will be used to provide financial assistance and services to either prevent individuals and families from becoming homeless or to help those who are experiencing homelessness to be quickly re-housed and stabilized; and

**WHEREAS**, the Director of Finance has certified that the appropriation to be transferred is not encumbered and is available for transfer.

**NOW, THEREFORE,**

**Section 1. *Be It Enacted*** by the County Council of Howard County, Maryland, that the following supplementary appropriation of funds is authorized and approved for the fiscal year beginning July 1, 2009 and ending June 30, 2010, as indicated below:
