1 **WHEREAS**, The County Executive has requested a transfer of appropriations in
2 the Annual Budget and Appropriations Ordinance for Fiscal 2009 transferring a total of
3 \$3,262,000 to capital project N3960 (Robinson Property Nature Center) from various
4 capital projects as follows: bond funding from capital projects N3105 (Meadowbrook
5 Park), N3107 (Rockburn Branch Park), N3932 (Western Regional Park), and N3968
6 (Cedar Lane Athletic Field Improvements) and transfer tax funding from capital projects
7 N3959 (Patapsco Female Institute Site Work), N3966 (Cedar Lane School Community
8 Center), and N3970 (Recreation and Parks Headquarters Expansion); and

10 **WHEREAS**, Section 609(b) of the Howard County Charter authorizes and
11 empowers the Howard County Council to make such transfers; and

13 **WHEREAS**, the Director of Finance has certified that the appropriation to be
14 transferred is not encumbered and is available for transfer.

18 ***County Code relating to the budgetary and fiscal procedures, the amount hereafter***

20 ***general County purposes specified and in sums itemized for the fiscal year beginning July***
