1       **WHEREAS**, Section 610 of the Howard County Charter authorizes and  
2 empowers the Howard County Council to make supplementary appropriations from the  
3 unexpended and unencumbered funds set aside for contingencies in the County budget;

6       **WHEREAS**, as part of the American Recovery and Reinvestment Act, the  
7 Governor's Office of Crime Control and Prevention has awarded the "Domestic Violence  
8 Investigator" grant to the County; and

10       **WHEREAS**, grant funds have been awarded in the amount of \$57,872 and the  
11 grant requires a match of \$41,889 in County funds; and

13       **WHEREAS**, grant funding will be used to pay the costs of one detective corporal  
14 position to be assigned to the Domestic Violence Section; and

16       **WHEREAS**, the Director of Finance has certified that the appropriation to be  
17 transferred is not encumbered and is available for transfer.
