1           **WHEREAS**, Howard County conveyed 0.157 of an acre of real property to the  
2 State of Maryland, for use by the State Highway Administration, by Deed of Donation  
3 dated November 20, 2014, and recorded among the Land Records of Howard County,  
4 Maryland in Liber 15889, folio 246 on or about November 21, 2014 (“the SHA  
5 Conveyance”); and

7           **WHEREAS**, the property that was transferred in the SHA Conveyance was part  
8 of an approximately 7.768-acre real property in Clarksville (“the Gateway Property”) that  
9 was the subject of Council Resolution No. 111-2008, approved on November 3, 2008,  
10 with the Resolution, based on Howard County Code Section 4.201, authorizing “sale” by  
11 the County Executive of the Gateway Property for the purpose of the redevelopment of  
12 the Gateway Property; and

14           **WHEREAS**, the First Amendment to the contract of sale for the 7.761 acres of  
15 real property to Greenstone Ventures II, LLC, dated November 27, 2013, obligated the  
16 County to “convey” the 0.157 of an acre to the State Highway Administration (i.e., the  
17 SHA Conveyance); and

19           **WHEREAS**, the Office of Law advised that the authorization for “sale” in  
20 Resolution No. 111-2008 constituted the necessary legal authority for the SHA  
21 Conveyance, for which the County received no State funds, because under Maryland law  
22 the sale of real property can occur in exchange for non-monetary consideration, as was  
23 the case for the SHA Conveyance; and

25           **WHEREAS**, while recognizing the Office of Law’s advice in this matter, the  
26 County Council nevertheless wishes to ratify the conveyance of the real property that was  
27 the subject of the SHA Conveyance based on both historical practice and, more  
28 importantly, Howard County Code Section 4.201(b), that delineates between conveyance  
29 and selling of property.

1           **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard

7 County, Maryland in Liber 15889, folio 246 on or about November 21, 2014.
