5 Community Investment Tax Credits to support services for at-risk populations in Howard County  
6 by providing services such as housing, food, and energy assistance, additionally, the Community  
7 Action Council of Howard County provides education and youth services through its Head Start,  
8 summer enrichment, summer youth employment, and other programs; and

10          **WHEREAS**, the Community Action Council of Howard County has applied to the  
11 Department of Housing and Community Development of the State of Maryland for approval of  
12 an allocation of tax credits for business entities and individuals that contribute to the  
13 organization, under the Department’s Community Investment Tax Credit Program; and

15          **WHEREAS**, the regulations of the Community Investment Tax Credit Program require  
16 that all projects receiving tax credits receive support from the appropriate governing body of the  
17 locality in which the project is situated.
