1       **WHEREAS**, Article II, Section 208(f) of the Howard County Charter provides that the  
2 Council shall adopt and publish such Rules of Procedure as it determines are desirable for its  
3 efficient operation; and

5       **WHEREAS**, the full text of all legislation and amendments is freely available to the  
6 public at the Council office or online; and

8       **WHEREAS**, eliminating lengthy passages that lack context and are therefore hard to  
9 understand will streamline the Journal making it more useful as a reference document; and

11       **WHEREAS**, the Council has determined that the Rules of Procedure must be amended to  
12 ensure that the Council operates efficiently and effectively.

14       **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,  
15 Maryland this 6<sup>th</sup> day of April, 2015 that the Rules of Procedure of the Howard  
16 County Council, set forth in Appendix A of the Howard County Code, are amended as follows:

20                               **Rules of Procedure for the County Council**

23       **Rule 1.011 - Council journal.**

24       When a bill, resolution or other legislative matter is journalized for the first time, its title  
25 shall be entered in full. Thereafter, subsequent journal entries for any legislative matter may be  
26 made by number and an abbreviated title. All amendments shall be ~~INDICATED~~ in the  
27 journal BY DESCRIPTION AND NUMBER when proposed. The name of every Councilmember  
28 introducing a bill or a resolution or moving to amend a bill or resolution or other legislative  
29 matter shall be entered on the Journal. Every question or motion presented to the Council for  
30 decision, and the title of every bill or resolution or other legislative matter considered, shall be

1 entered upon the journal.

3 **AND BE IT FURTHER RESOLVED** that these amendments to the Howard County

4 Council Rules of Procedure shall take effect on passage of this Resolution.
