





### **Alison Buckley Biographical Statement**

Alison Buckley has served as the Associate Vice President for Enrollment Services at Howard Community College since 2011. In this role she is responsible for the office of records, registration and veterans affairs. During Ms. Buckley's tenure with the college, HCC has been selected as a Military Friendly School by Victory Media for three consecutive years. This honor is awarded to the top 15 percent of post-secondary schools in the country that are extraordinarily responsive to the needs of military students and their families. Also under Ms. Buckley's leadership, the college established a military and veterans lounge where military students can relax, socialize and gain support for one another.

Prior to joining Howard Community College, Ms. Buckley was the Executive Director of the offices of admission at the University of Baltimore. Here she oversaw all graduate and undergraduate admissions activities for the Yale Gordon College of Arts and Sciences, the College of Public Affairs and Merrick School of Business. Ms. Buckley also served as the Managing Director of graduate recruitment at the Robert H. Smith School of Business at the University of Maryland, College Park as well as the Director of Business Development for the executive education division. Prior to moving to Maryland, she worked at The Wharton School at the University of Pennsylvania.

A 2013 graduate of the Premier class of Leadership Howard County, Ms. Buckley continues to volunteer on Leadership's Life Long Learning committee. She is also an active volunteer with St. Peter's Episcopal Church in Ellicott City and serves as the first Vice President of the Alumnae and Alumni Association of Randolph College.

Ms. Buckley received her bachelor's degree from Randolph College (formerly Randolph-Macon Woman's College), a master's degree from the University of Delaware, an M.Phil. from the University of Dublin, Trinity College and an MBA from the University of Maryland, College Park. She is currently pursuing a doctorate in organizational leadership at Northeastern University.
