**WHEREAS**, debt service on outstanding bonds issued by the County for the Community College in Fiscal Year 2014 is projected to be \$7,461,014; and

WHEREAS, \$6,642,846 in debt service will be paid directly by Howard County government; and

WHEREAS, Section 16-301 of the Education Article of the Annotated Code of Maryland requires the County governing body to review and approve the budget of the Community College; and

**WHEREAS**, Section 16-304 of the Education Article of the Annotated Code of Maryland requires the County governing body to make appropriations for the Community College by major functional categories.
