Good evening, I am Chris Oxenham residing at 15261 Bucks Run Dr. in Woodbine, 21797. I am speaking tonight in regards to my potential appointment to the housing commission.

I am a lifelong Howard County resident with the exception of 4 years where I attended the University of Maryland and received a finance degree from the Smith School of Business. When I returned to Howard County I started my own financial advisory firm as an entrepreneur. I have been in business here in the County now for 8 years and our firm has over 85 million in assets under management and I serve as the CEO. Along the way I have received further professional designations including my series 7, series 66, and CHFC and am also licensed in the life and health marketplace. Currently, my business is located in Glenelg.

Through my business experience I have gained extensive knowledge in both the equity and fixed income marketplace. For the housing commission my extensive knowledge and work in municipal bonds will be of great value to the commission. Especially given the difficult period we are entering in the municipal bond marketplace. As we will see in the coming months we are about to enter a period of increasing interest rates making bond issuance tricky and bond values volatile. This is especially concerning to muni bonds not backed by the full faith and credit of the government like the bonds the housing commission will issue for funding. To have an expert in the fixed income markets would be where I could add value to the commission.

In addition I have great interest in the renew Howard program. In working with several of my clients who invest in property in this county we have often discussed the real estate conundrum in Howard County. A lot of prime real estate was built from 1990 – 2010 which in addition to the great school system here has led to a skyrocketing real estate value and a very high entry point to live and rent in this county. There are substantial amounts of properties in aging communities that need work. As counties across the country have just focused on building we have seen older communities get left in the dust. To me revitalizing these communities is of utmost importance and if you can do it in a way to incorporate affordable housing into the fold you can really create a value added element to the county. We need to make sure lower income residents have access to decent housing and if we can revitalize old neighborhoods at the same time we can really grow and give our lower income residents a good lift. It is my understanding of the Renew Howard program that things were not in motion to be sustainable. The county was in 16 million of debt and 2 million from this program was moved because there were no applications for the fund. This makes sense. We need to have a sustainable long term plan to fund this program. I feel I have the professional background and expertise to help do just that and make this program thrive. You need people at the table who can come up with long term sound funding strategy.

I stand here tonight willing to serve and make this a better county. Thank you to the councilpeople who I spoke with over the last few days. I really appreciate the open dialogue from you and I look forward to serving this county with integrity and all I have.
