

## Catherine Strawley- Environmental Sustainability Board

Hello, my name is Catherine Strawley, and I will be attending Howard High School as a senior this Fall in Howard County District 2. I have been nominated for the position of the new student member of the Howard County Environmental Sustainability Board for the 2015-2016 year.

It is my belief that we are all very capable of making positive change in the community to contribute to the overall improvement of the health of the environment.
