Good Evening Madam Chairperson and Council Members,

You all know me as the Executive Director of Linwood Center. You are most familiar with our new school and the strides we have made in Howard County and neighboring counties to provide special education services to students on the autism spectrum.

I am here this evening to request that the Council endorse Linwood's application to the Maryland Department of Housing and Community Development's Community Investment Tax Credit program. By doing so, you will facilitate a win-win situation for our donors and for Linwood, at no cost to Howard County. If Linwood is approved for the program, donors will receive a state tax credit of 50 cents on every dollar they donate to Linwood. This incentivizes potential donors to become actual donors and it incentivizes actual donors to increase the amount they donate. Linwood's programs and services are funded by various state agencies. These funds pay for the bare essentials. As a nonprofit agency, we rely on the additional funds we receive through grants and contributions to improve the quality of these programs and services.

Linwood has a much broader scope of services than its school program. I would like to spend the remainder of my time talking about adult services.

Linwood provides a supported employment program for adults living with autism. We provide job training and secure employment for our adult program participants. This includes our Linwood Boutique on Main Street in historic Ellicott City. Linwood also owns and operates 16 homes in neighborhoods that include Columbia and Ellicott City. Our children reside in four of those homes; our adults reside in twelve of them.

Adults with special needs have the same rights and responsibilities as all of us. They have the right to live and work in their community and to access resources in their community. Unlike children with special needs who are entitled to programs at the government's expense, adults have no entitlements. The funds they receive through the state pay for the bare essentials only.

If our application to the DHCD is approved, the contributions Linwood receives through the Community Investment Tax Credit Program will be used specifically to enhance the homes in which our adults reside. We love our adults, but they tend to be very hard on furniture, walls, floors, fixtures, and the like. It is only through the contributions we receive that we can keep our homes livable. Our adult residents



should be able to experience a quality of life that all of us who live in Howard County have come to expect.

Finally, I want to remind the Council that Linwood has always been a good steward of the support we have received from Howard County and the State of Maryland. As a result of the generous grants we received, we have established vital partnerships with the Howard County Public School System as well as other agencies throughout the County and the State. The Council's endorsement of our application to the DHCD will help Linwood improve the lives of many Howard County citizens. I thank you in advance for your support.
