Workshops/Presentations/Grants/Awards

Conducted/presented dozens of workshops/lectures on archaeology for classroom teachers, the archaeology society of Maryland (ASM), and general audiences. Topics included: the archaeological method, the role of archaeology in the identification and preservation of prehistoric and historic sites in Howard County, the importance of public involvement in the preservation of our antiquities, including cemeteries.

Received over \$40,000 in grants for conducting archaeology field work, historic research and for producing exhibits and displays to increase public awareness and understanding of Howard County's prehistoric and historic past, as well as the need for preservation of our cultural resources.
