1 WHEREAS, the Maryland Transit Administration ("MTA") is the designated 2 recipient in Maryland for grants under the Federal Transit Act; and 3 4 WHEREAS, the Administrator of the MTA of the Maryland Department of 5 Transportation is authorized to make grants to counties and to local governments for 6 projects as part of a mass transportation program; and 7 8 WHEREAS, such grants are awarded through a contract for financial assistance 9 that will impose certain obligations upon the County, including the provision by the 10 County of the local share of the project costs in the program; and 11 12 WHEREAS, the County will file an application for Operational and Capital 13 funding assistance with the MTA for some or all of the following grants under the 14 Federal Transit Act: Metropolitan & Statewide Planning grants (Sections 5303, 5304 and 15 5305); Urbanized Area Formula Program grants (Section 5307/Large Urban); Bus and 16 Bus Facilities grants (Section 5309 and 5318); Formula Grants for Other than Urbanized 17 Areas grants (Section 5311); Americans with Disabilities Act (ADA) Funding Program 18 and the State Special Transportation Assistance Program (SSTAP); and 19 20 WHEREAS, in accordance with the provisions of Title VI of the Civil Rights Act 21 of 1964, it is required by the United States Department of Transportation that, in 22 connection with the filing of an application for assistance under the Federal Transit Act, 23 the applicant give an assurance that it will comply with Title VI of the Civil Rights Act of 24 1964 and the United States Department of Transportation requirements thereunder; and 25 26 WHEREAS, the County's goal is that minority business enterprise be utilized to 27 the fullest extent possible in connection with these projects and programs, and definite 28 procedures shall be established and administered to ensure that minority business shall 29 have the maximum construction contracts, supplies, equipment contracts or consultants 30 and other services.

Analysis of Council Resolution No. 143-2015

The purpose of Council Resolution No. 143-2015 is to authorize the Administration to apply for Federal and State grant funds from the Maryland Transit Administration. During our review of the resolution and Mr. Powell's memo to Mr. Robbins, dated August 27, 2015, we were able to determine the following:

• The County is required to provide matching funds for some of the grants as described below.

0	Large Urban Public Transportation Program	25%
0	Section 5311 Rural Public Transportation Program	No match required
0	Americans with Disabilities Act	10%
0	Statewide Special Transportation Assistance Program	25%
0	Section 5309 Capital Assistance Program	10%

- Regarding the Section 5309 Capital Assistance Program grant,
  - o The grant request of \$460,800, as stated on the memo, is greater than the grant funding of \$50,000 included in the FY 2016 capital budget.
  - o The capital budget will have to be adjusted if the funds are received.
  - o The capital project designated to receive the grant revenue is C-0332 Bus Stop Improvements. It does not provide funding for C-0323 Transit Buses as stated on the memo.
- The total amount of grants to be requested will be \$4,654,989 of which \$4,194,189 is operating and \$460,800 is capital. The total required County match will be \$608,959 of which \$557,759 is operating and \$51,200 is capital.
- The County overmatches all of these operating programs by a significant amount. For the four operating programs detailed above, the County provides \$4,522,724 of funding above the required County match.

Please be advised that the Office of Transportation supports Council Resolution No. \_\_\_\_\_ for the application to receive Federal and State grant funds through the Maryland Transportation Administration (MTA). The MTA requires that an Authorizing Resolution be completed by all jurisdictions that receive funds from MTA's Large Urban Public Transportation Program, Section 5311 Rural Public Transportation Program, Statewide Special Transportation Assistance Program (SSTAP); Americans with Disabilities Act (ADA) and Section 5309 Capital Assistance Program.
