# **Support Howard County Stormwater Fee Elimination**

On Tuesday, January 19, the Howard County Council will hear public comment and testimony concerning the elimination of the stormwater fee as defined in <u>CB 52-2015</u> and its associated resolutions, <u>CR 181-2015</u> and <u>CR 182-2015</u>. Just recently, the Howard County Chamber Board of Directors voted unanimously to support this legislation for reasons outlined in <u>the accompanying letter</u>. We now are asking that you do the same by <u>contacting your County Council members</u> and requesting they support CB52-2015, and/or by <u>attending the meeting</u> and letting your voice be heard.


#### What CB 52-2015 Does <u>NOT</u> Do:

Does not reduce the commitment to meeting the Total Maximum Daily Load (TMDL)

requirements of the <u>U.S. Clean Water Act</u>, which describes the value of the maximum amount of a pollutant that a body of water can receive while still meeting water quality standards. Alternatively, TMDL is an allocation of that water pollutant deemed acceptable to the subject receiving waters.

What CB 52-2015 Does:

- Creates more equitable <u>funding sources</u> for this important program;
- Removes the convoluted measuring and tracking of commercial and agricultural property as well as the disproportionate burden to commercial property;
  - Allows for a significant reallocation of funds from supporting staff positions to use of funds to mitigate the impacts in older developments without the modern storm water management provided today.
