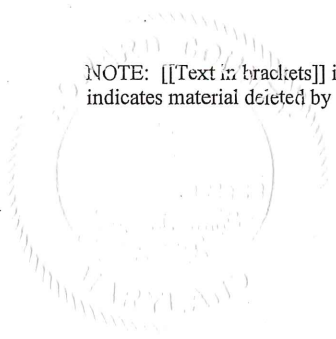

14 (f) *Credit for Pre-Employment Military Service.* A participant shall receive credit for additional  
15 years of eligibility service and years of creditable service to the extent of [[his or her]] THE  
16 PARTICIPANT'S military service, to a maximum of four years, if the participant:

- 17 (1) Has [[at least six months of]] military service that precedes [[his]] THE PARTICIPANT'S  
18 employment with the County and that has not been recognized under section 1.416A;
- 19 (2) Is not entitled to a military pension from the United States Government (except for  
20 benefits under a Reservist's Pension described in Chapter 1223 of the United States  
21 Code) or any other foreign government on account of such service; and
- 22 (3) Has 20 years of eligibility service (determined without regard to [[his or her]]THE  
23 PARTICIPANT'S military service).


