AN ACT amending the Pay Plan for Howard County; adding steps to the pay scales for members of a certain collective bargaining unit that were recently negotiated in a collective bargaining agreement; providing for the application of this Act; and generally relating to the Pay Plan for Howard County.

1 **WHEREAS**, Sections 706 and 707 of the Howard County Charter and Section 1.301 of
2 the Howard County Code provide for the adoption of and amendment to the Pay Plan for
3 Howard County, which allocates each class of positions to the appropriate pay grade, and which
4 establishes rules for administration of the Pay Plan for positions within County government; and
5

6 **WHEREAS**, under Section 1.301(c) of the County Code the Pay Plan, and any
7 amendments thereto, are adopted by the County Council as attachments to the Council Bill
8 through which the County Council exercises its legislative action on the Pay Plan; and
9

10 **WHEREAS**, pursuant to recent negotiations, the County agreed to add two steps to the
11 pay scale for the members of Howard county Local 1810 of the American Federation of State,
12 Local and Municipal Employees (“Local 1810”); and

14 **WHEREAS**, the Pay Plan is amended to reflect the additional steps (steps 18 and 19) for
15 Local 1810.

17 **NOW, THEREFORE,**

19 *Section 1. Be It Enacted by the County Council of Howard County, Maryland that the Pay*
20 *Scale for Local 1810 is amended as shown in the attached.*

22 *Section 2. And Be It Further Enacted by the County Council of Howard County, Maryland,*
23 *that the Act shall apply beginning with the first pay date after July 1, 2015.*

25 *Section 3. And Be It Further Enacted by the County Council of Howard County, Maryland,*
26 *that this Act shall become effective 61 days after enactment.*
