Today is kind of a big deal for me.

The legislation before you represents, at least to me, a confluence of the things I care most about for my community and what I have spent years working on, in many capacities and with many partners.

Before you are several pieces of legislation that seek to implement the vision laid out in the Downtown Columbia Plan, an expansive, thoughtful, and collaborative document that was the result of years of discussion. The shared vision for Columbia's future laid out in this plan has served as a beacon for me and many others in this community, a goal – or rather a set of goals – for what ought to be, and the legislation we're discussing tonight is a measure of the will we have for making it so.

I am here tonight as an individual and speaking solely for myself. I can't, however, escape the roles I play in this community, because they are fundamental to who I am.

So in the interest of full disclosure, I currently work the Executive Director of the Downtown Columbia Arts and Culture Commission, an entity that was formed as part of the Downtown master plan to enhance the cultural significance of both Merriweather Post Pavilion and Downtown Columbia, more broadly.

I am also a co-founder of the Save Merriweather movement that started thirteen years ago in response to a problem the TIF legislation before you can solve: Parking.

I am also a member of the Howard County Housing Commission, which, I believe, is the finest developer of affordable and mixed income communities in Howard County. Period.

Lastly and most importantly, I am a father of two young children. And what I want more than anything for my kids is to grow up in a city full of opportunity, the same kind of city Jim Rouse envisioned more than 50 years ago, which is not, as some would have it, a city of cul-de-sacs surrounding a mall. But rather a city that is dynamic, vibrant, diverse, innovative, and that embraces change with optimism and steers it with collaboration.

While I recognize that this was, perhaps, an excessive introduction, I'm not sharing it to bolster my credibility or credentials, but to be honest about who I am and where I'm coming from. Because I think it's important, essential even, that we assume honesty and good faith when considering public policies that are as comprehensive, complex, and consensus-driven as these.

With all that said, I am here to ask you to support the proposed tax-increment-financing package and the consensus plan for affordable housing. I'll speak first about the TIF.

The idea of a TIF approach to public facilities was envisioned in multiple places in the plan – explicitly in Chapters 2 and 4, but like many development specifics, the details of a TIF were not worked out. They have been now.

While I certainly support the TIF's parking garage on the grounds that it will help answer the question about Merriweather's parking, my support for it is much broader and deeper and has to do with a fundamental flaw of Downtown Columbia.

Which is that nearly all of the parking is controlled by only two corporations, and public access to parking owned exclusively by private entities cannot be guaranteed. And this is especially true if people are coming to Downtown for non-economic reasons – that is to engage in civic, cultural, or educational activities rather than for work or shopping.

So public parking is critical to the viability of Downtown Columbia as a thriving center for our city. This proposal would fulfill our shared "park-once" vision for Downtown Columbia in which all residents can gather and enjoy the benefits of Downtown's redevelopment and the company of each other.

I have certainly heard the concerns of others that this TIF would represent a developer give away, but I strongly disagree with that notion. This TIF is largely funding a public asset that can promote the public good without competing for general fund dollars. Frankly, it seems like a no-brainer.

I have also heard concerns that its funding roads and all other developers pay for roads. But I think this is a unique situation --- we are not building a subdivision, but a city. And the road improvements to support Downtown are a significantly different endeavor than what is built elsewhere.

And its worth noting that even a portion of tax revenue going to the TIF, there would still be future tax revenue going into the General Fund.

While I would like to lend the bulk of my support to the TIF, I would also like to express support for the joint recommendations for affordable housing for many of the reasons you have heard from other supporters – for the certainty of this proposal, for the inclusion of the housing commission as a significant partner, for the broader spectrum of incomes it would include.

I recognize that a significant concern about the plan is its complexity. It has a lot of moving parts, but I think this is to be expected with something like this, for a few reason:

First, it is a consensus plan. Whether it is a complete community consensus is another question, but there is no doubt that this plan is the result of a ton of discussion and work by a lot of interested, intelligent people and organizations. Anytime this many players sit around the table and have this many disparate interests, the result is likely to be complex.

Moreover, housing policy is complicated. It cuts across so many disciplines and policy areas and addresses some of the most profound issues we face as society.

Also, as it relates to the comparison with MIHU, Downtown Columbia is one of the most expansive development projects this County has seen since Columbia. Getting it right should require a different

approach. This is not a subdivision of 100 townhouses... we're building a Downtown.

Finally, Columbia is complicated. New Town Zoning, the Columbia Association, the Downtown Columbia Master Plan... these are all complicated. And they've also contributed to make this one of the best places to live anywhere.

That last part applies to both the joint housing recommendations and the TIF. These are ambitious, complex pieces of legislation that did not arrive on your desks willy nilly. They are the product of years of work, discussion, negotiation, analysis, and give and take.

That said, I'm not asking for you to rubber stamp them by any stretch. It is my sincere hope that you approach these as all other stakeholders have — openly with diligence, thoughtfulness, and in good faith, but also with a firm grasp on the bigger picture and the goal we all share.

Which is to make Downtown Columbia a true downtown and a befitting heart for city we all love.

Thank you for taking time to share your thoughts on the Downtown Columbia package the County Executive filed last week for the Council's consideration. This latest effort to redevelop downtown Columbia, including building affordable housing units, come to us after it became clear that an appropriate amount of affordable units would not be achieved with the last plan approved in 2010.

The package has many critical elements, one of which is affordable housing, others include building roads, infrastructure, office space, market rate housing, and other public assets like open space, arts and entertainment venues, a fire station, and library. In short, there is much to consider, including the benefits of a plan to sets a percentage (Councilperson Terrasa's approach) or one that delivers a set number of affordable units (the package submitted by the Executive). Over the coming weeks, and likely months, the public discussions on the plans will be conducted, in the hopes that the benefits and challenges of both plans become clear to the community and decision-makers. From the public process, the Council, as well as the Administration may find areas they'd like to change based on what we learn.

I hope that you'll remain interested and engaged throughout the process and will come out to testify (or submit testimony) for one of the hearings the Council will conduct.

Hello. My name is Megan Freeman and I have worked for Merriweather Post Pavilion for the past six years. I am writing you in support of Merriweather Post Pavilion and the public parking garage. As a supervisor, and as a member of the event staff before that, I have seen firsthand how acquiring a parking garage for patron usage would greatly benefit the patron's experience, the surrounding community centers, and the venue itself, all of which I am sure you will hear all about at the hearing this evening. While all of the above are immensely important, I would like to highlight one other facet of Merriweather that would benefit from a parking garage, which is the staff. In order to demonstrate the effect that the lack of patron parking has had on the Merriweather staff, I would like to share a story with you about my own experiences.

One year ago in August I was working at the venue's "North Gate" (directly across from the mall) when I was assaulted by a patron. According to the patron he had run out to make sure that his car had not been towed from the mall- despite knowing that Merriweather has a no re-entry policy. When he came back, instead of trying to reason with my staff or myself, this patron ran through the gate and when I tried to stop him, he turned around and punched me. While many things could have prevented this from occurring, it is undeniable that the lack of parking was a major contributor. This concert, like many others, was a sold out event and our lots were and are not big enough to accommodate those numbers, thus causing people to take chances parking elsewhere. Unfortunately this wasn't the first problem that was caused by people leaving to check on their cars and, unless something changes, I can guarantee that it will not be the last.

It is almost an every show occurrence when myself or one of my other colleagues must deal with multiple patrons who are upset about either the distance they had to walk after parking their car, having to gamble with parking at the mall/ Whole Foods, or the lack of parking in general. While we empathize with these patrons, this fight is getting pretty old, especially when it comes to those who decided to park in more risky places such as the mall or Whole Foods. Patrons have threatened to sue us if their car gets towed, they have gotten in our faces, and have used a lot of profanity to get their points across. I understand that I have voluntarily accepted a job at this venue, and I do not regret it, but it is pretty disheartening to get berated by patrons for something that we truly have no control over. Many of us are mature enough to brush it off, but we also have several employees who are 15, 16, and 17 years old who do not deserve to deal with this, especially when there is a fairly simple solution.

Members of the Council, I urge you to consider this other very important variable when making your decision regarding the potential parking garage for Merriweather. I love Merriweather, I think it is a great place and truly helps make Columbia, Maryland stand out. Please help make it an even better place for patrons, citizens, and employees alike!

Council Chairperson Ball and Council Members:

My name is Steven W Sachs and I live at 2811 English Bond Court, Woodstock, Maryland, 21163. I have resided in Howard County since 1973. I worked for The Rouse Company for 12 years as an employee and as an outsourced contractor for managing their Risk Management function for 19 years. I also operated a business in Howard County, HoneyBaked Ham Café and Store (formerly Heavenly Ham) for many years. I presently am employed as an Executive Vice President for Willis Towers Watson, and international firm with 39,000 employees and offices in over 120 countries. I am Director of the Real Estate, Hotel, and Gaming Practice in North America. In that function, I travel extensively to major cities within North America and am engaged with may large owners of real estate assets. Howard Hughes Corporation is not a client of Willis Towers Watson. On a personal note, I strongly believe the a quality education "for all" and affordable housing are critical to our country's ultimate success and survival as a great nation.

In Howard County, I have been actively involved in non- profit boards over the years with a special interest in education, health and wellness, and the arts. I also feel strongly

about the need for sustainable affordable housing and my firm has many clients in that business. When Jim Rouse was involved with Jubilee Housing, which in some ways was the predecessor for his creation of what is now Enterprise Community Partners, I handled the risk and insurance function for the two initial apartment building purchased and rehabilitated in Washington D.C. I saw how Jubilee not only rehabilitated derelict building, but also created community on a broader scale.

When the Downtown Columbia Plan was being debated before the Council during County Executive Ullman's administration, I testified before the council and was actively engaged in the process and attended many of the council's legislative sessions. It was an interesting time for me as I had been disengaged from the community for a number of years as my wife Sam, was battling cancer. She had lost that battle, and the spirited discussion on the Downtown Plan was a signal for me to become re-engaged in the community. I also remember it fondly, because it is where I first really got to know my wife, Lee, who was working for the Howard County Chamber of Commerce.

I remember the discussions over the affordable housing component of the plan and the final agreement on the plan submitted by GGP and supported by the housing organizations and ultimately the Council. It seemed like a win-win for all concerned, but in reality it has not worked. That is what happens in 30-40 year plans. When something does not work, we re-adjust and as Jim Rouse would say, "you make lemonade out of lemons". When Jim developed the first Columbia Plan with the help of the best and the brightest that he could find, he perceived a build out as possibly a 12 year development cycle. The economy and social fabric of the country changed over the years as did the pan. I was with the company during many of those ups and down of the US economy and the social changes taking place in our community and country.

I never for a moment believed that the plan agreed upon by the Council would not need some amendments as it execution unfolded. Some would be required to fix issues for both parties. The key to fixing problems is to find a win for both sides that ultimately is fair and benefits the community. Inherently the means the solution will not be perfect.

I believe that Council Bills 103 and 104 address is Affordable Housing issue in that context. The Council approved the original housing component by a 5-0 vote. As it became clear that the agreed upon structure would not achieve the desired results, the Council requested that the Downtown Housing Corporation find a solution and empowered them to negotiate with Howard Hughes Corporation. The DHC's members have considerable experience in Affordable Housing experience g from a variety of disciplines. They also brought experience with respect to affordable housing structures and financing across the United States. For its part the developer hired Greg Fitchitt,

who was experienced in affordable housing, to determine from their perspective, how the problem might be resolved, while maintaining the economic viability of this project.

From my conversation with some of the participants, it is clear to me that the negotiation were complex and difficult. In the end, the Board recommended a proposal, which they believe is both viable for meeting the community's affordable housing for Downtown Columbia and/supports the overall downtown development.

While some will disagree with me, I believe that the small increase in density is a long term win for both affordable housing and for downtown Columbia. While I understand Council Person Terassa's desire to go back to the original 15% requirement, I do not support it and feel that if the Council felt that was the way to go, it should not have requested the DHC to undertake the complex discussions and negotiations that have in fact led to a viable solution.

I also want to address one issue that has been discussed, which is the use of "public" land on which to build some, if not all of this addition housing. I see this as an increasingly viable and accepted structure across our country. In urban and upcoming areas, the high cost of land, even with the tax credit structures can make it very difficult to successfully structure projects affordable housing projects. I think that it is an appropriate use of County assets.

As I previously commented, I travel across the USA and visit many cities that have ongoing redevelopment. One thing that I have always noted is that vibrancy occurs when there are people congregated in areas. Cities are fun because of the interaction of people in safe environments, where there is a variety of activities, one of which is the watching of other people. That desired picture also comes with some predictable issues, one of which is also traffic. Infrastructure such as parking, roads, and planning for walkable landscapes and alternative transportation can minimize the impact. However, there will never be a "golden" book traffic free zone, as some might want. In my opinion, it is well worth the trade-off. As my friend and wife, Sam used to say to me, Steve," it is not just about you." I think about that often as the future Downtown Columbia, which I hope to be able to enjoy "parts of", is about building a city that is even more diverse than now, by attracting young adults and professional to both want to work, live and play in a vibrant downtown, befitting of what Jim Rouse might have envisioned.

The TIF legislation, Council Bill 105 and 56 provides for an acceleration of the infrastructure creation. It seems to me that the County is protected under the terms of the TIF. As I understand it, until the assets are earning sufficient tax revenues to pay for

the bond's interest costs, the Developer will pay for them. In addition, once the asset is completed, if it is not providing sufficient tax revenues to suffice the interest payments, and additional levy is placed on the developer, who is responsible for paying it.

I read Liz Bobo's comment that The Rouse Company never required the County to front money for infrastructure. I respect the former County Executive and State Delegate, but I might offer some addition qualifying comments. For the most part HRD (The Developer of Columbia), who had Connecticut General as it deep pocket, was creating infrastructure that was limited to specific areas where land sales would repay the infrastructure investment on a more accelerated basis or "return on investment". I would also add The Rouse Company in the development of large projects, both Shopping Centers and mixed use, used Special Taxing Zones or TIF's to pay for the initial investment of infrastructure improvements. Two examples that I remember was Park Meadows in Denver and Bridgewater Commons in New Jersey. TIF's can be abused if not properly structured, but it "seems" as if this TIF is trying to look out for the possible issues that might impact the County.

As the Chair of the last two Howard County Spending Affordability Committees, I agree that we do not want to expose the County's operating budget to the downstream impact of borrowing and we have recommended a reduction in borrowing in the last two reports. The use of a properly structured TIF addresses that issue, while allowing the County to accelerate the development process of Downtown Columbia, which will ultimately bring needed additional commercial property tax revenue to the County as well as creating a vibrant downtown for people to live, work, play, and "grow".

Dear County Council Members,

As a very long term resident of Columbia, since 1979 I've witnessed a lot of growth. I'm no enemy to builders as my mother made a very respectable business in interior design for most all of the builders in Columbia both residential and commercial. As a kid, I played in and around the mall when it still had a five and dime store, McRory's and Wilde Lake Village Center still had all small business owners who knew me. Now I avoid the mall as its size over whelms. Wilde Lake has less than a hand full of small business owners left. Columbia seems packed with people who rush by in cars.

As a resident of Hickory Ridge, I cherish the quiet paths and longtime neighbors, whose lives matter to me and mine to them. My daughter attends Wilde Lake Middle where I am amazed that even in a GT math class, she must sit up front in order to hear over the din of about 25 disruptive students. How many more students are projected at the middle school with this new development?

As I understand, this proposal to build a high rise on top of a fire station is an expedient way to fulfill a builders promise to provide affordable housing. Surely a promise that needs to be fulfilled. I spoke at the last months Town Hall meeting with Council representative, Mary Kay Sigaty. She said that her own daughter would love to live in this proposed high rise over the fire station. Her appreciation for the plan is also based on its expediency. Perhaps the location is good fit for 20 something's to live in. Especially if they worked at the mall. What a fit, a day job and night life all within walking distance! Although my question is who will be the likely residents of this high rise?

According to The National Low Income Housing Spotlight, 2012,

"Elderly households (those including a household head or spouse who is at least 62) are a large part of the tenant population across all programs. Nearly a third (30%) of public housing residents are elderly, as are nearly half (46%) of residents in Project Based Section 8 housing. Households including a member with disabilities are also a size-able group, composing one-fifth (21%) of those living in public housing, and over a quarter (28%) of voucher recipients. Both of these household types are very likely to be living on a fixed income such as Supplemental Security Income or Social Security and thus will need housing assistance for most of the rest of their lives. A little more than a third (35%) of public housing households include children under the age of 18, and 43% of households with vouchers have children."

And from a much older article in *The HUD User Periodical*, 1989,

"To summarize: 52 percent of all public housing is occupied by elderly or handicapped households, 43 percent by households with children (including some with handicapped heads of household), and the balance by nonelderly households without children." https://www.huduser.gov/periodicals/ushmc/spring95/spring95.html

Despite this age of the later article, if the statistics have not changed dramatically in over 14 years, I doubt that they have changed dramatically in the 4 year span from 2012 to 2016. In this case then living over a fire house sounds pretty disturbing and stressful to me if I was either elderly or a single parent. And if the high rise houses younger folks, how would that fit the fire workers needs, to sleep and focus on taking care of themselves so they can be our dependable first responders? It seems like a bad fit either way with little likelihood of symbiosis. Everyone needs a "sense of place". This is a term used by city planners to characterize a feeling people have about a place that makes it seem special or unique, as well as a place to foster authentic human attachment and belonging. Healthy soil has enough organic matter that when it rains, the water settles slowly to the roots of plants. Hard and un-porous soil sends water right off its surface. And, from injury or illness recovery comes from lots of small steps to rebuild strength, flexibility and functional movement.

Let's not rush a plan that has not been worked through properly. Jim Rouse had a great <u>dream</u>, not only a bottom line. Make sure that the plan has full foresight into issues like projected school enrollment, enough parking, traffic leeway, and quality if fit for those already present. Clearly, the current lack of affordable housing speaks to a disregard for the community as a whole. But as an old time resident of Columbia once told me, "Howard County has come down with a bad case of "Afluenza" and bottom line decisions alone are not the cure, they're the cause.

- Our open space being given away to a private developer for the purpose of building residential
 units on that space. It seems the only one to benefit will be the developer. I also question the
 legality. When I moved here, there was no question open space is Protected Space!
- The traffic and parking on Banneker Road is already overwhelming. It is a dead end road leading

Dear Council Members Ball, Fox, Sigaty, Terrasa, & Weinstein

I am writing in relation to the bills related to the Downtown Columbia Affordable Housing currently before the council. I am a 40-year-old software developer working in Dorsey Search for the past 17 years. In 2008, after years of feeling locked out of the Rockville/Gaithersburg area I purchased a home in the Banneker neighborhood because I could reduce my commute as well as get "More for my money", even though it was still quite expensive. After feeling locked out of Montgomery county, not being well enough off to purchase, not bad enough off to qualify for the affordable programs, I fully understand and support the creation of affordable and especially workforce housing options.

I do however 100% disagree with the proposal contained in the administration plan to replace the Banneker fire station with a new fire station containing upwards of 200 additional residential units on top regardless if it is low income or luxury units. It is not possible to place a building of that size in our community and preserve the small neighborhood feel we have today. Many of the other sites do not appear to effect a fully developed neighborhood like the fire station proposal.

As others have testified, Banneker Rd is already quite full of street parking with at times very limited views due to cars parked near intersections. This road was never intended to support a large residential building. We have one way in, one way out. Do we need larger new fire station in downtown?

absolutely I think most in Wyndham would agree after recent events. This is not the way to do it.

I have heard that this is not a done deal, but I believe that once passed it will happen. Money will start flowing, the zoning and planning process, site plans will change but we will end up with a large residential complex that will most likely overwhelm the neighborhood, especially with the reduced parking requirements. Columbia does not have the public transport of Rockville Town Center, reducing parking will be a disaster. I frankly do not see how you build such a building on the fire station lot without a massive unground garage and build on every possible square foot of land allowed.

I still have not recovered the value of my home since the 2008 crash, adding a large multi-story residential complex is not going to help it recover either.

I viewed the Council work session from Monday however and was pleased to see our neighborhood was discussed.

On a secondary note, I have seen the construction of the new office/parking garage on the corner of Little Patuxent and Broken Land. I hope the future of the Crescent development will not contain similar dull grey concrete/glass bland generic architecture. If you truly want to create a thriving downtown, this will not attract visitors.
