My husband and I have been going to Dale Martins' for several years now. We were referred to her by the breeder of our two Norwich terriers. This breed is double-coated and requires hand stripping, rather than normal grooming, a technique which is not commonly done by commercial groomers. We travel over an hour from Centreville, VA every five weeks in order to have our two dogs stripped. Dale does a wonderful job providing this service. It is a tedious and physically demanding process, requiring anywhere from 45 minutes to 1 1/2 hours per dog to complete. If we couldn't come to her, it would be nearly impossible for us to find another groomer in the area who performs it.

It is our understanding that the main problem is the matter of her having her business on .999 of an acre, rather than a full acre, the county's legal requirement. Closing her business would be rather unfair in light of the fact that she is less than a percentage away from meeting this requirement.
