1 **WHEREAS**, the Howard County Council adopted Council Resolution No. 31 – 2016
2 which requested that the Environmental Sustainability Board prepare a report which evaluates
3 studies performed by the School System's Indoor Environmental Quality Advisory Committee
4 and any indoor environmental air consultants hired by the School System to inspect for the
5 presence of mold in Howard County Public Schools; and

7 **WHEREAS**, the County Administration offered to begin an assessment of air quality in
8 school buildings using funds from the county's systemic renovations budget to contract with an
9 environmental consulting firm to conduct air quality assessments in 12 schools to examine for
10 the presence of mold; and

12 **WHEREAS**, the Howard County Department of Public Works retained Skelly and Loy,
13 Inc. to conduct the air quality assessments of Centennial Lane Elementary; Elkridge Elementary;
14 Laurel Woods Elementary; Lisbon Elementary; Pointers Run Elementary; Rockburn Elementary;
15 St. John's Lane Elementary; Talbott Springs Elementary; Glenwood Middle; Mount View
16 Middle; Glenelg High and Wilde Lake High during June 2016, and the reports were posted on
17 the Howard County Department of Public Works website on August 8, 2016; and

19 **WHEREAS**, in order to conduct a comprehensive independent review of all of the
20 studies pertaining to alleged incidents of mold at Howard County Public Schools, the County
21 Council would like for the Environmental Sustainability Board to include the studies by Skelly
22 and Loy, Inc. in its review.

24 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
25 Maryland this _____ day of _____, 2016, that the Council requests that the
26 Environmental Sustainability Board expand the scope of its report requested by Council
27 Resolution No. 31 - 2016 to include the twelve studies by Skelly and Loy, Inc., as well as the
28 August 18, 2016 letter to the Department of Public Works regarding Recommendations for June
29 and July 2016 Indoor Air Quality Assessments.

1 **AND BE IT FURTHER RESOLVED** that the County Council of Howard County,
2 Maryland extends the deadline for the report to be provided to the Council and the County
3 Executive to October 31, 2016.
