Dear County Executive Kittleman,

I am writing to urge you to keep an open mind regarding funding for the education budget. I've been told that you have stated that you will not fund the budget coming from our Board of Education. I sincerely hope that what I hear is wrong and that you haven't actually made a decision prior to hearings.

As a career educator, I've seen contracts go unfunded. I've seen furloughs. I've been denied increments. Even when the increments were funded, I spent many years on sitting on "frozen" steps, receiving no pay increase. Health care contributions have increased. Pension contributions have increased. Pension benefits have decreased.

At the same time, the demands of the work continues to increase. New programs, new technology compliance requirements and the burdensome evaluation system requirements take time and distract me from my students, offering no professional growth for me and no value to students. Top candidates for the profession are weighing the benefits with the demands and we are missing out on some great candidates. We are working in a hostile environment where our expertise and our passion is minimized.

I'm nearing the end of my career, so I'm asking on behalf of my colleagues and our students.

The salary scale that was agreed upon (a minor miracle in itself) evens out the increases, removes the frozen steps, and approaches a salary that would help us compete with Montgomery County to attract and retain high-quality professionals.

When the economy was down, we understood and took the hit with everyone else (and a bigger hit than many). Now is the time to retain our newest teachers. The cost of teacher turnover is absurd. The person who will replace me will hold the trust of our community to nurture the leaders of tomorrow. I can't imagine a more important investment in our future.

My name is Kelly Risolo and I am a 3rd grade Instructional Team Leader at Centennial Lane Elementary School. I have been teaching for ten years. My entire teaching career has been spent at CLES. I adore the students, staff, and community, and I am so very grateful for the job that I have. I love my job. I teach, inspire, facilitate, and help to shape good citizens. My time, energy, blood, sweat, and tears go into my job. There has never been a day in my ten years of teaching that I have worked my contract hours. There is no way to accomplish everything that I need to accomplish for my students during my contract hours. I spend time after school, my evenings, and my weekends grading, planning, creating, analyzing data, and communicating. This is time that I take away from my family, including my two-year-old son. In addition, I spent an excessive amount of time last year, specifically, on my teacher evaluation artifacts and rationales. My personal time that I typically devote to grading and planning engaging lessons for my students was occupied by the tremendous amount of work and preparation that went into the evaluation process. For all of these reasons, I request that you fund the HCPSS budget to ensure dedicated teachers like me, get the compensation that they need and deserve.

Hello County Executive Kittleman. My name is Ross Chakrian and I am writing to you today to ask you to please thoroughly consider the proposed HCPSS Board of Education budget for FY17.

I have been one of the physical education teachers at Waverly Elementary School here in Howard County for the past 6 years. Providing my students with a quality physical education program is extremely important to me. On a daily basis, I do my best to maximize activity time while engaging my students' bodies and brains in various activities that are designed to challenge them and get them to think. This is no easy task with up to 60 students at a time in a gym that is the 4th smallest of the elementary school gymnasiums in HCPSS, but I make it work. In order to provide my students with the quality instruction and activities they deserve, I have found myself doing more and more work outside of my contracted work day as I seemingly need to come up with more and more creative solutions year after year as changes are made to our PE schedule and enrollment continues to rise. I usually get to work an hour before my contracted time and spend about an hour each school night getting things done that I was not able to during the school day. I also spend about 4 hours on most weekends doing work for school as well. All in all on an average week, I often find myself doing about 14 hours of work for school outside of my contracted hours for which I am not compensated for. Going into the teaching profession, I was fully aware that there would be some work that I would have to do on my own time. However, I was also under the impression that I would be compensated in such a way that I would be able to support and start a family of my own in the future. After teaching for 6 years with HCPSS my salary has risen only \$6,000. With my wife being a teacher as well in neighboring Anne Arundel County, we are finding it very hard to make ends meet after all of our bills and college loan payments are made.

Mr. Lemle has notified members of HCEA that you have stated to both him and the Superintendent that you do not plan on fully funding the proposed Board of Education budget for FY17. The overwhelming majority of teachers in Howard County put in as much of their own time as I do or more to provide their students with the best possible experience within their classrooms day in and day out. HCPSS teachers deserve the pay raises that are weaved into the proposed budget and I implore you to do the right thing for the teachers of our great school system.

The proposed Board of Education budget for FY17 is an encouraging one.

The past ten years has been difficult on educators in the early years of their careers. They have seen multiple pay freezes, and a delayed step, while the cost of living has continued to rise.

Many question whether or not to invest in the time to get a master's degree to stay in a field that is not compensated as well as other fields.

This delay in pay increases has happened against a backdrop of more and more demands on teachers, from additional testing to additional analysis of those tests to adjust instruction to meet the needs of every student. This is in addition to the regular demands of grading and preparing lessons, much of which is done "off the clock" because there are so many things that can only be accomplished at school, like meetings, organizing materials for instruction, and working with small groups of students. We answer parent emails at night and attend student concerts and STEM nights, which are not part of our contractual obligations, but which we do because we support children.

I work for students even during the summer, when I am not paid. That is the time I work to create engaging lessons, read novels that I know my students will enjoy, and create new math lessons to clarify a difficult concept more clearly. I do these things even without pay because they require a creativity that is difficult to summon amidst the daily demands of school year.

Do I love my job? In a word, yes. I have the perspective of someone who has worked in another industry. I came to education from business. I have an M.B.A. and a Master of Arts in Teaching. So I know the pressures in education exceed anything I did in Marketing. Teaching requires more of everything I know how to do as a manager, parent, communicator, and even performer.

At last night's meeting, you indicated that the money is not there. You gave examples of things that would have to be reduced or eliminated in their entirety to come up with the money. I suggest that the money be found by reducing expenses a little bit in a lot of different areas. In looking at the budget, the lion's share of the county's money is spent on sewer and water. As an example of finding cost reductions in other areas, maybe if you were to ask workers to identify where money is wasted, they could identify areas for savings. Often it is the people at the front lines who can identify waste best.

The justifications are typically the same, touching on key business factors such as budgeting and revenue. Fair enough. There isn't always adequate money to go around and meet all needs, let alone wants. But why does the business model of education allow for increased workload year after year without compensation? Why is it that the only thing which has trickled down to me in my eight years of teaching in Howard County has been more work, more red tape? I grade and plan at hours considered ungodly here in America; I spend hours advising non-school-sponsored clubs and activities for which I am refused even mileage reimbursement. And everyone persists in telling I me how

"rewarding" it must be, and they "thank me for all that I do." Should I continue accepting that degree of patronization? I'm often too tired to write e-mails like this, even when segments of them are prefabricated. And I imagine some segments of our population count on that. Am I paranoid? I sure hope that doesn't permeate my lesson plans in spite of my professionalism. Look: I'm not denying the need for the savvy tools of business, nor even the art of negotiation in these matters. I'm just questioning their use as rationalizations. Budgets have been tight, but are beginning to loosen. Where's the trickle-down effect of a strengthening economy?

Here you've got a budget proposal that is fair and is agreed-upon by factions which do not always come together. It was a beacon of hope for what often seems like a distraction in our midst. I hope you'll see the opportunity here as an Executive to make a firm declaration of support for a system (not even just a workforce with wages) that is way too often scapegoated by financial conservatives. Either directly or indirectly, it affects our children.

As a National Board Certified educator with an undergraduate degree from an Ivy-League institution and a graduate degree from a prestigious and pedagogically-obsessed School of English, I've done my part to better my situation and not simply bellyache about my pay. But I still work two jobs. And I've put off getting married at least once, when my car died and I had to dip into my savings in order to get to my school and the hockey rink to stay ahead of the rat-race curve. But I liked the rush and don't mind the grind. And I'd hate to sound entitled to a raise (or entitled to anything for that matter), but I'm tired of being treated like a political pawn. I'm happy and proud to be an educator in a community that ostensibly cares about its student population. I'd like to see a commitment, because as I approach ten years in Howard County, offers from outside are starting to sound mighty enticing.

I began my career in education as a temporary employee at West Friendship in first grade, working with an amazing girl who has Down Syndrome. I immediately fell in love with special education and my passion for teaching children with special needs has only increased over the years. I worked incredibly hard, going above and beyond my job description. I also decided to go back to school, and began taking classes for Special Education, paying my way one semester at a time.

Three years later, I had to leave West Friendship due to student numbers, but I was fortunate enough to get a position as a Student Assistant at Gorman Crossing Elementary. It was a huge step because I was finally employed by the county and I was able to receive the wonderful benefits that the school system provides. After two more years of hard work and persistence, I finally reached my goal of getting a position as a Special Education Paraeducator.

I am still in school, and I am still living with my parents because I cannot afford to live in Howard County on my own on the salary that I make, after working in the school system for 6 years. I love my job. I can see the difference I make every single day. But I am also exhausted and discouraged because I feel so undervalued. I work in one of the most challenging early childhood programs in the county and every day is physically and mentally draining. And yet at 27, I can't even afford to move out. But I stay because I don't do it for the money. I do it because it's important and because I love my students.

The proposed salary increases for the next two years would help me to get closer to being able to afford to live in the county that I love and work in. It would also help in making me feel a little more appreciated. My mom has talked very highly about you, and I know that you are on our side. I also know that budgets are tricky and that things in government are not always as they seem. So I wanted to share my story with you in the hopes that it might give you a little more encouragement to do everything you can to secure this win for us.

We go above and beyond every single day to make our schools the best in the state and top ten in the nation.

I was so excited this year because it was the year that I finally received a raise after being frozen at the same salary for three years. It was a big jump and I was really looking forward to getting more money to help pay for the rising cost of groceries and food in general. Well, I can't adequately explain in words the disappointment my family and I felt when we saw that this "big raise" we had been waiting for, amounted to only about \$100 each month. Every night the restaurants of Howard County are filled and seem to have wait lists. I wonder how so many people can afford to eat out so often, because I know that I certainly can not afford this luxury, yet I work at least 80 hours per week. This new contract will not make us rich, but will provide fair compensation and a decent standard of living for the educators of Howard County.

You said yourself that you once student taught at Dunloggin Middle. I'm sure you remember how difficult and time consuming of a job teaching can be. I am responsible for making 135 students college and career ready on a daily basis. One meaningful assignment for one class day takes 5 minutes to grade and enter into Canvas at a minimum. That totals ELEVEN hours to grade one assignment. I love my job but our compensation is far from matching our effort. As a social studies educator, I am responsible for creating the responsible, educated citizens who you want to make good decisions when it is time to vote. Don't you think I deserve to be compensated as well as the other public service officers in the county?

When people think about Howard County, they think about the quality of education that is provided by our educators. What is really sad is that many of our educators can't afford to live in Howard County and take advantage of the great school system.

Our jobs get harder every year and require us to work harder and longer, yet we are not compensated fairly. In addition, to never having time to take lunch or any kind of break to make a doctor's appointment, I am expected to spend countless hours grading papers and dealing with student problems after my work day. To the Council:

Superintendent of Schools, Dr. Reneé Foose, has submitted a request for a \$ 838.7 million for the 2017 year. County Executive Alan Kittleman has countered with the following:

The Board of Education's response (at Thursday's board meeting) was to float ideas like increasing class sizes and instituting furlough days.

My suggestion? Return public relations funding to 2012 levels as an austerity measure. Return legal staffing to an in-house team with a limited amount of money to spend litigating against parents. That should save a boatload of money right there. In addition, halt the expansion of the Elementary School Model to seven more schools, which appears to have been slipped into the budget with no communication whatsoever to the community.

As you fulfill your task of reviewing the budget, I ask that you:

***** halt funding for the expansion of ESM without community input.

*****support Mr. Kittleman's priorities in the school budget: full funding of special education, teacher raises, and instruction.

These are our tax dollars that you are charged with spending responsibly. I believe is never inappropriate to request that our elected public officials do their utmost in the wise stewardship of our resources. I hope you agree.

Dear County Council members,

During your budget working meeting today, you will likely be aware of Dr. Foose's intent to hire 56 new teachers. It sounds like such a wonderful idea. What it belies, though, is an attempt to expand her Elementary Model School program into an additional 7 schools, without public input of the program ever being allowed.

Those representing central office will say that those opposed to the program are a tiny special interest group who don't care about struggling students. This could not be further from the truth. We are an advocacy group who care a lot about all students, and we happen to believe that cutting arts programs by 25% in elementary school is a serious detriment to our youngest students. Time and again arts programs are shown to have the same effects as this program is purported to achieve, higher test scores and closing of the achievement gap, but the arts offer so many additional benefits over stuffing more data driven learning into little brains.

We believe that the results of this program in the current schools should be examined before more money is spent on expanding it. We believe that stakeholders deserve at least a voice in the expansion of this program, and to understand the trade offs. We believe that just because Anne Arundel or Baltimore County offers less arts instruction does not mean we should, we send our children to school here, in Howard County, to get a "world class" education. We should be expanding the arts.

We do not oppose world language instruction, but we do oppose the trade off. Please consider putting a hold on this project, through the budget process, until the community has an opportunity to understand and discuss it. Should it be what the community wants, then it should be fully funded in future years, including the second step funding of additional middle school world language teachers it requires. If you, like we, are unsure that the trade off is worth it, then please do not fund the expansion.

Board Seeks Public Input for School System Budget Cuts

The Howard County Board of Education is committed to transparency in its budget process and is announcing a new opportunity for public input. The Howard County Public School System (HCPSS) has developed an innovative online tool to allow parents, staff and community members to identify their priorities and the school system's most pressing needs.

"As the Howard County Council considers at what level to fund

the school system, we want every member of our community to have an opportunity to express their priorities,” said Board Chairman Christine O’Connor. “We need the community’s input as we make difficult decisions related to proposed cuts to the school system’s budget.”

The Board of Education submitted an \$856.4 million operating budget request to the County to support the needs of a growing and increasingly diverse student body. The Board’s request would provide support for all students and salary and benefits totaling \$734.3 million for more than 8,400 excellent teachers and staff, while sustaining the success of a system that enjoys a national reputation for quality teaching and learning.

The school system is now facing \$50.4 million in proposed cuts included in the County Executive’s budget proposal. With 85.7 percent of the budget directed to employee salaries and benefits, a cut of this magnitude is difficult to make.

With this [interactive survey tool](#), available through May 17 on the HCPSS budget page, parents, staff and community members can review specific areas in which to protect, cut or restore funding. The areas for review include staffing levels, new or expanded educational initiatives, enrichment activities, materials of instruction, transportation, maintenance and operations, and salaries and benefits.

“This innovative new tool helps us take an important step forward in engaging stakeholders in the process of setting funding priorities, and provides far greater participation in the budgeting process than has ever before been possible,” said HCPSS Superintendent Renee A. Foose.

The recommendations will be used to provide a summary of the community’s budget priorities. Board members will use this input to help make reductions to the FY2017 budget during the upcoming work sessions.

The Board of Education’s next public hearing on the FY2017 Operating and Capital Budgets, and FY2018-2022 Capital Improvement Program is scheduled for Thursday, May 12 at 7:30 p.m. The County Council is scheduled to adopt the budget on Thursday, May 26 at 10:30 a.m.

This email will be brief as I am nursing an 8 week old baby with RSV. The idea that I am even writing this email while caring for my sick infant should give you an idea of how important I think this issue is and how passionately I feel that HCPSS needs oversight..

I appreciate both the Council and the County Executive's leadership on the HCPSS budget. I am a product of the HCPSS school system (OMHS 1997) and a proud stepparent of an AHS 2015 graduate as well as a parent of two future HCPSS students who are both under the age of 2.

I am very troubled as a taxpayer and education stakeholder that the school system is being less than transparent with their budgeting process. I appreciate that the Council and the County Executive Office has limited opportunities to exercise oversight over the school system and I am appreciative that the Council and the County Executive have all made an effort to hold the school system accountable for its stakeholders since it appears they are unwilling to otherwise do so.

I am disgusted that the school system drafted a survey proposing furloughing teachers when those costs were specifically fully funded. My brother is a teacher in Baltimore County and I know how hard teachers have to work. Using students and teachers as tools to make a point is very weak leadership in my opinion. Budgets are complex - my professional background is in finance. However the school system seems to want to hide behind that complexity to avoid accountability.

I find the health benefits fund and its inaccurate estimates particularly troubling. I wouldn't give my teenager an allowance of 500 a week to go to the doctor and let them reallocate it to movies if they didn't go - that is kind of what the health benefits fund feels like.

Thank you for your leadership on this issue and asking questions and holding the school system accountable for its answers. I won't be able to attend any hearings in person, but I am watching those that I am able via the streaming site, and I wanted to send an email voicing my support. The questions you are asking are those that the community needs answered.

A closing note that I also appreciate your funding of the Howard County ER - unfortunately I've had to visit the pediatric ER twice this week and I am thankful we are continuing to invest in this facility. The wait times in the pediatric ER are generally great and I thank you all for working through funding to keep it that way and to improve the adult ER wait times..

Dear council members,

I testified in support of the HCPSS budget proposed by the County Executive, but I feel it necessary to write to you again. This administration had over \$10M in no-bid contracts last year (I can send you the folder full of fact sheets from HCPSS to prove it). They have spent millions on Gallup surveys, social media consultants for the Superintendent and Board of Ed, renovations to the Board room, cultural proficiency contractor, leadership skills contractor for the BOE, additional student testing [MAP testing], contractor to evaluate IT infrastructure, Harvard Fellows to evaluate testing data, (all of which were no-bid).

The Legislative audit report was given to HCPSS months ago, and yet, the administration is delaying their report. As Council members, I would hope that you ask for the report from this financial audit before you vote on the next budget. I know that it was given to HCPSS because I called the supervisor of the Legislative audit group on March 18th and he told me that the report had been provided to HCPSS weeks before my call.

So many of their expenditures should be considered for cuts LONG BEFORE the idea of increasing class sizes and dolling out furloughs to teachers.

The idea that their massive budget request, if not funded, would be a cut to education is infantile in its argument. The County Executive proposed a budget that is \$32M over what they spent last year. The statement from the BOE chair that they can't afford to keep the lights on is maddening and an obvious scare tactic.

Please don't simply give away our tax dollars for their wasteful programs.
